a) A game room may operate between the hours of 8:00 a.m. and 5:00 p.m. Monday through Friday

b) Game rooms shall ensure that doors, gates or any other entrances are locked or otherwise secured in a manner such that the public does not have access outside of allowed hours of operation.

Game rooms shall ensure that doors, gates, or any other entrances are unlocked during operating hours.

c) An owner of a game room found operating in violation of Section 3.2(a) or 3.2(b) shall have the game room permit immediately revoked.
