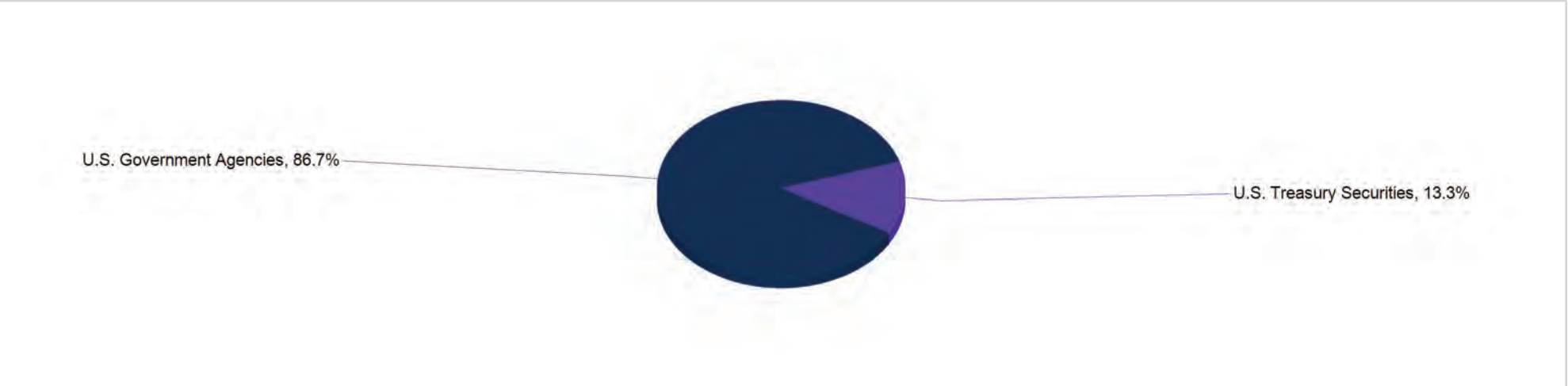

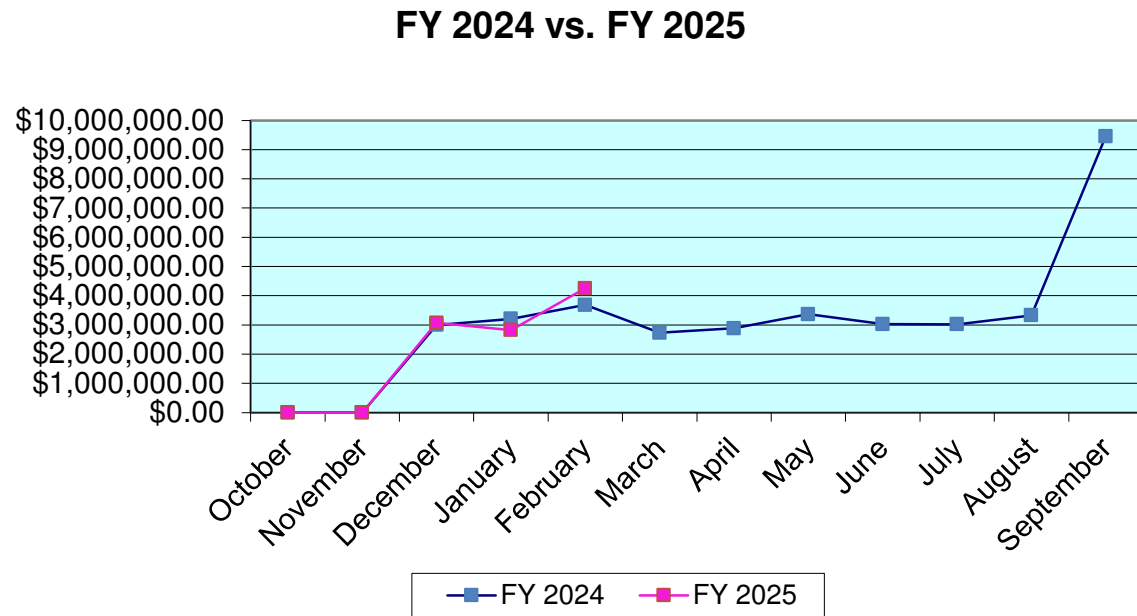

As of February 2025

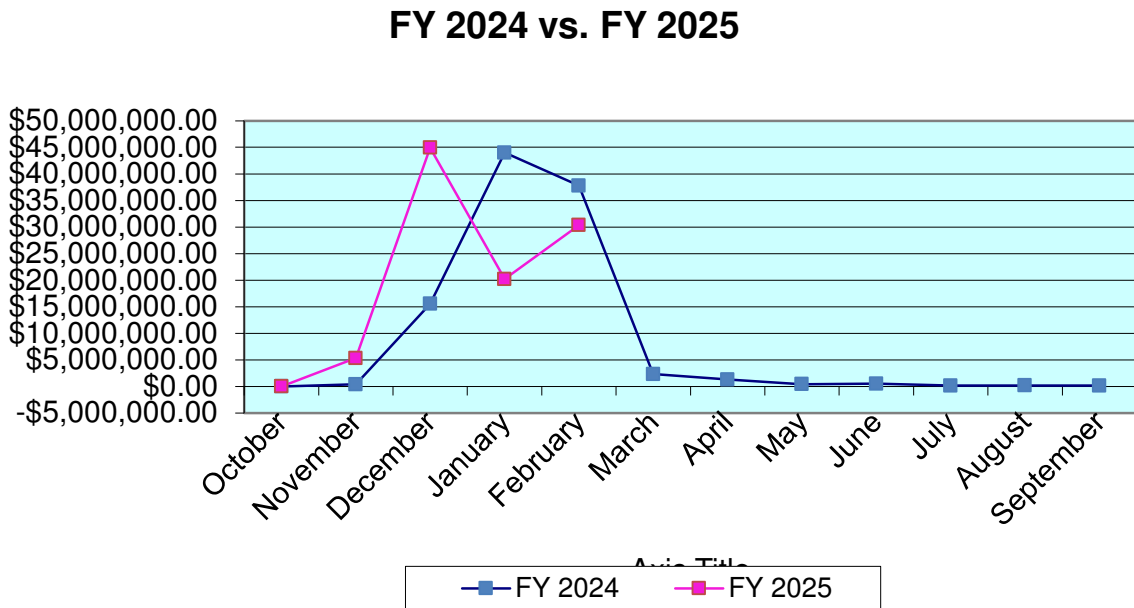
