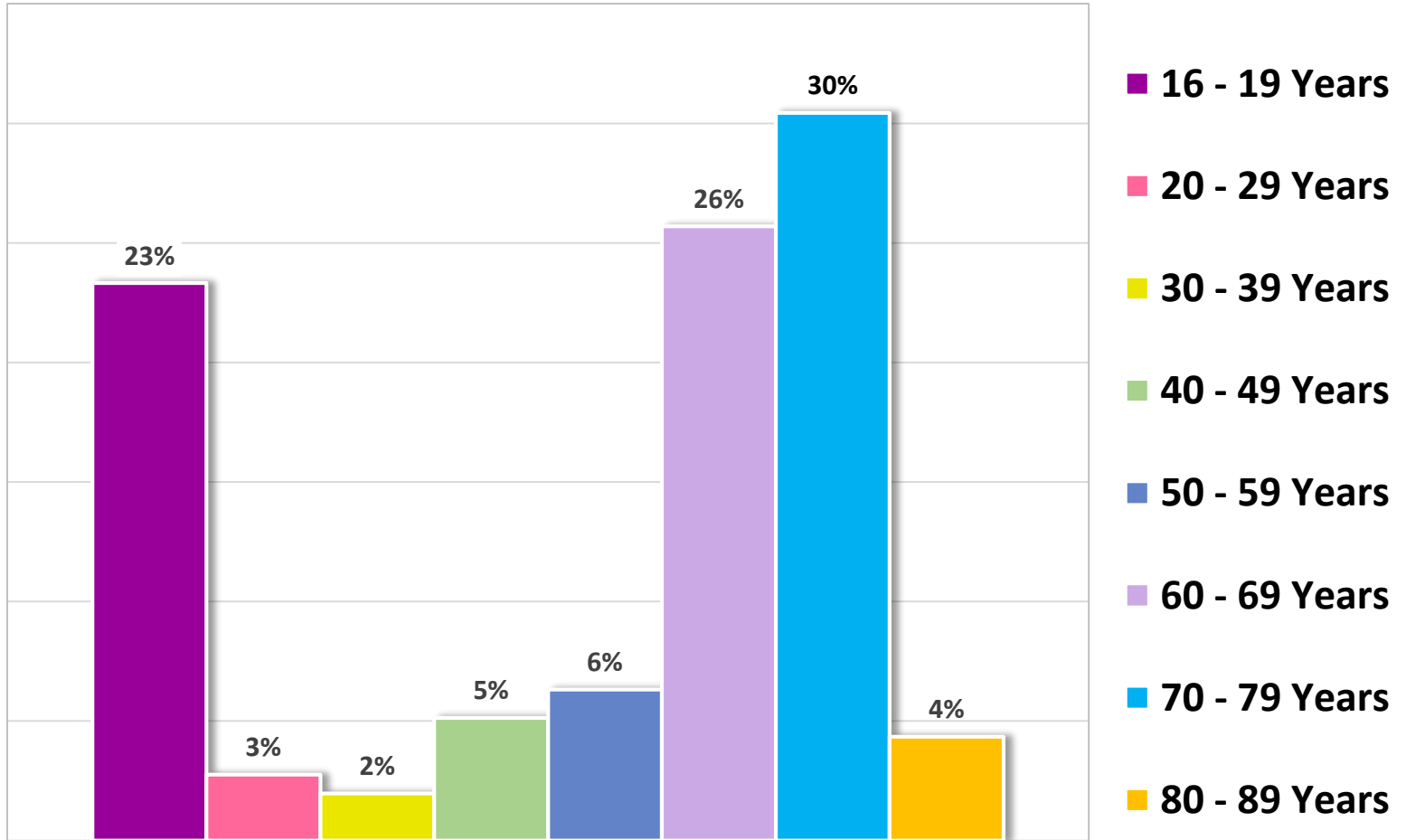

# Statistics

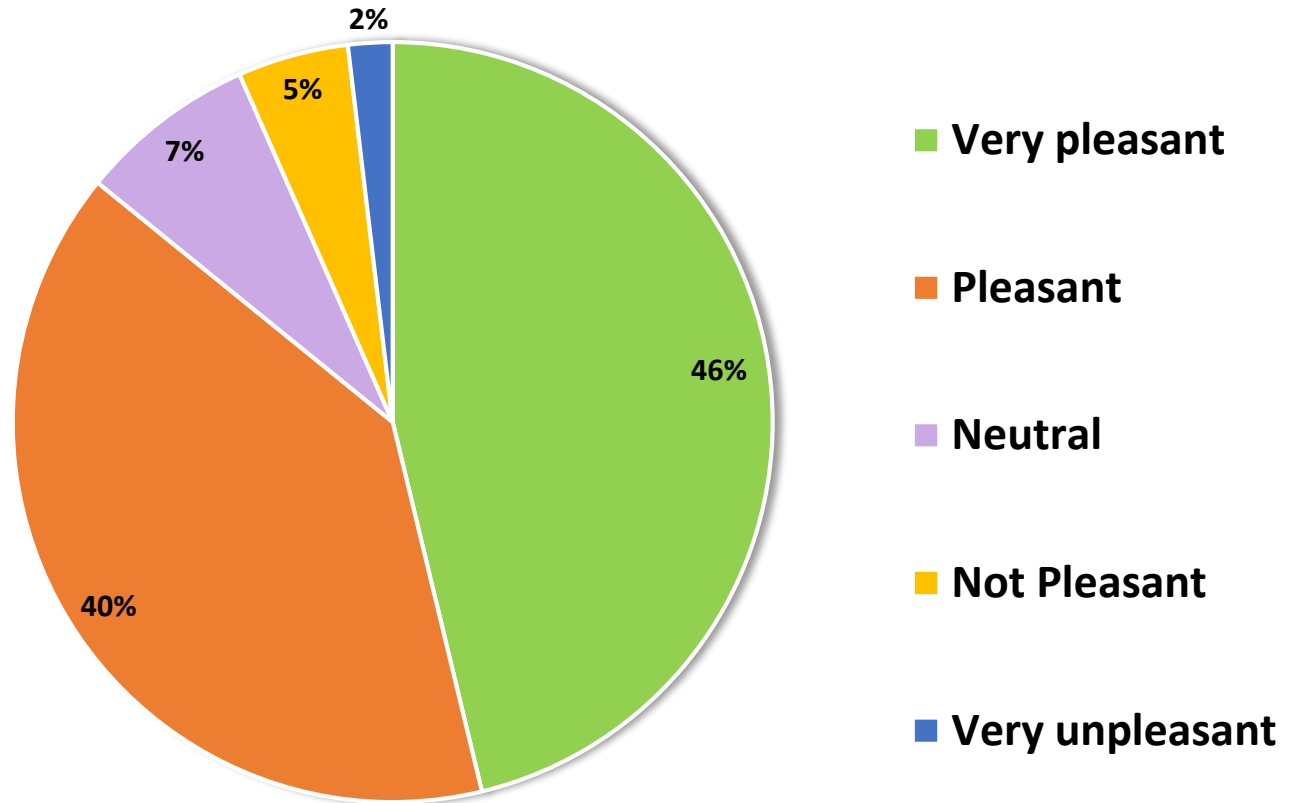
- 253 Surveys were sent out

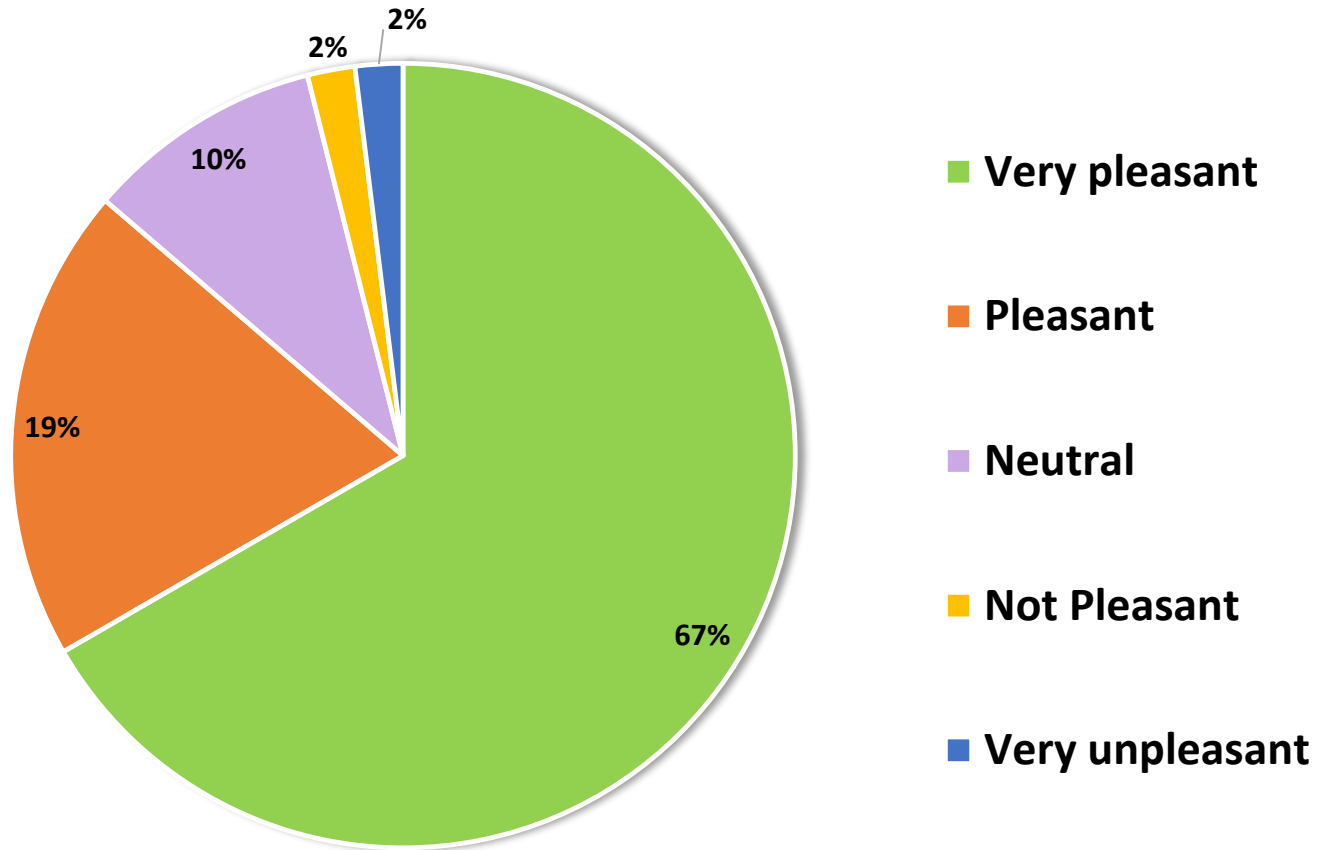


# Please rate your overall experience working this past November 2022 Election.

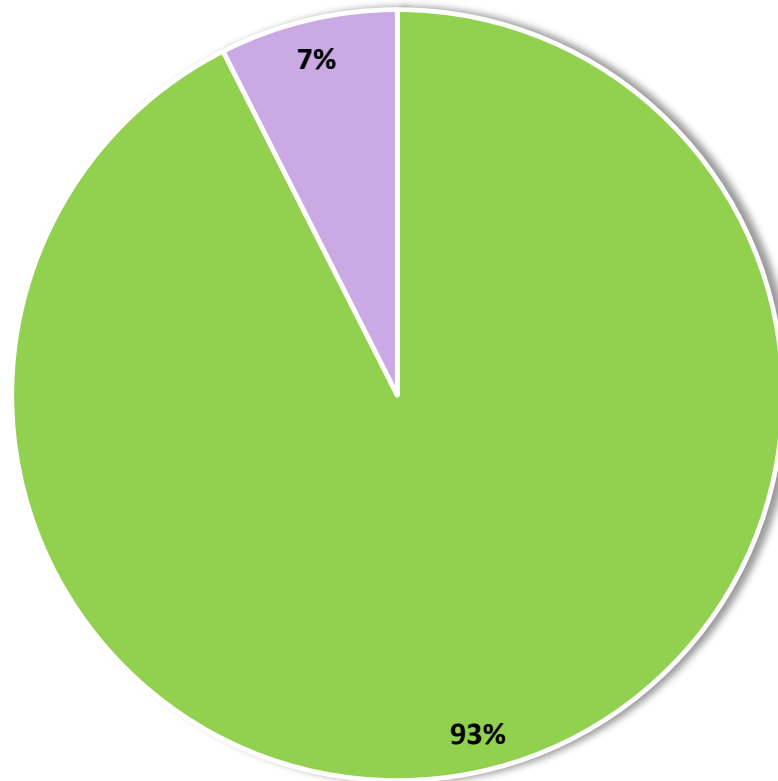

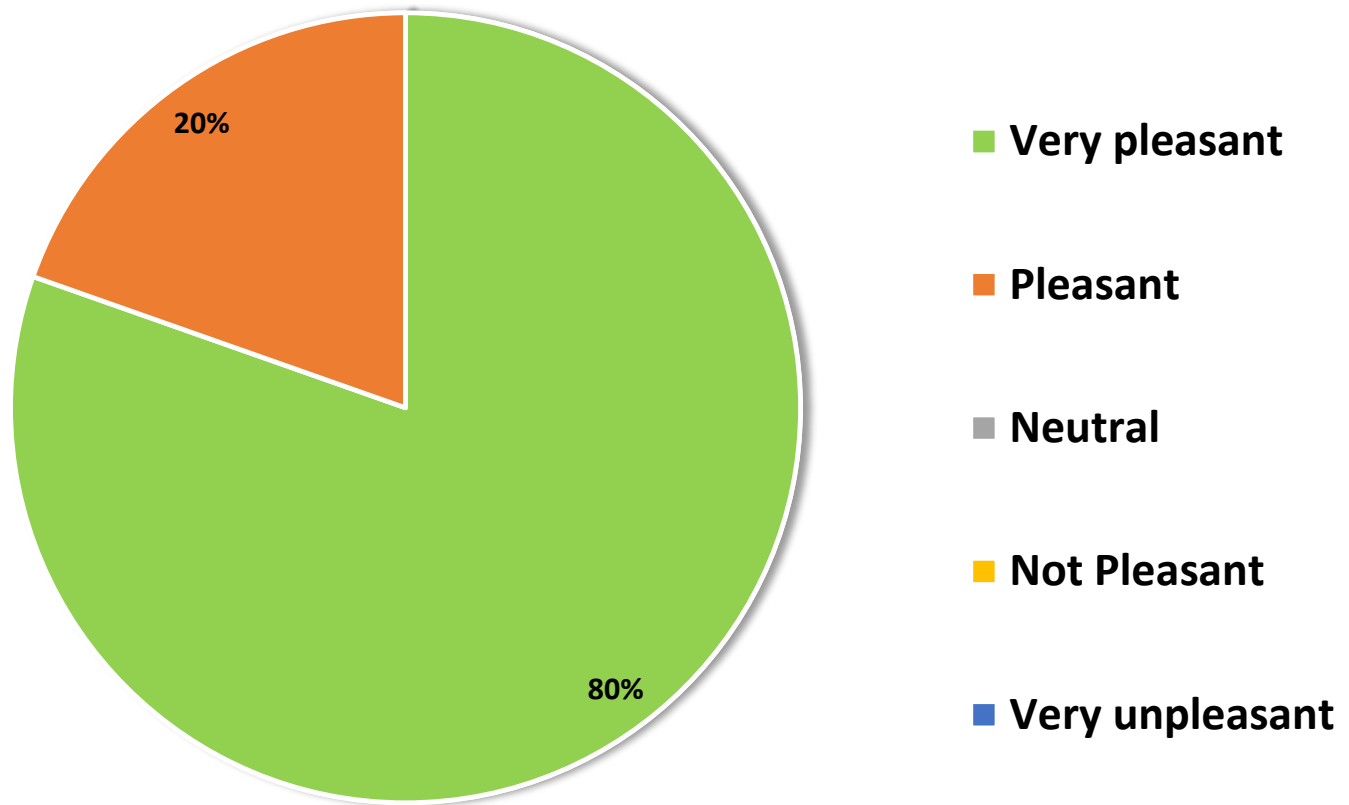




# Do you believe, in your opinion, the two lead clerks worked together well?

Early voting leads had personality clashes. Election day leads were very compatible.	Purple

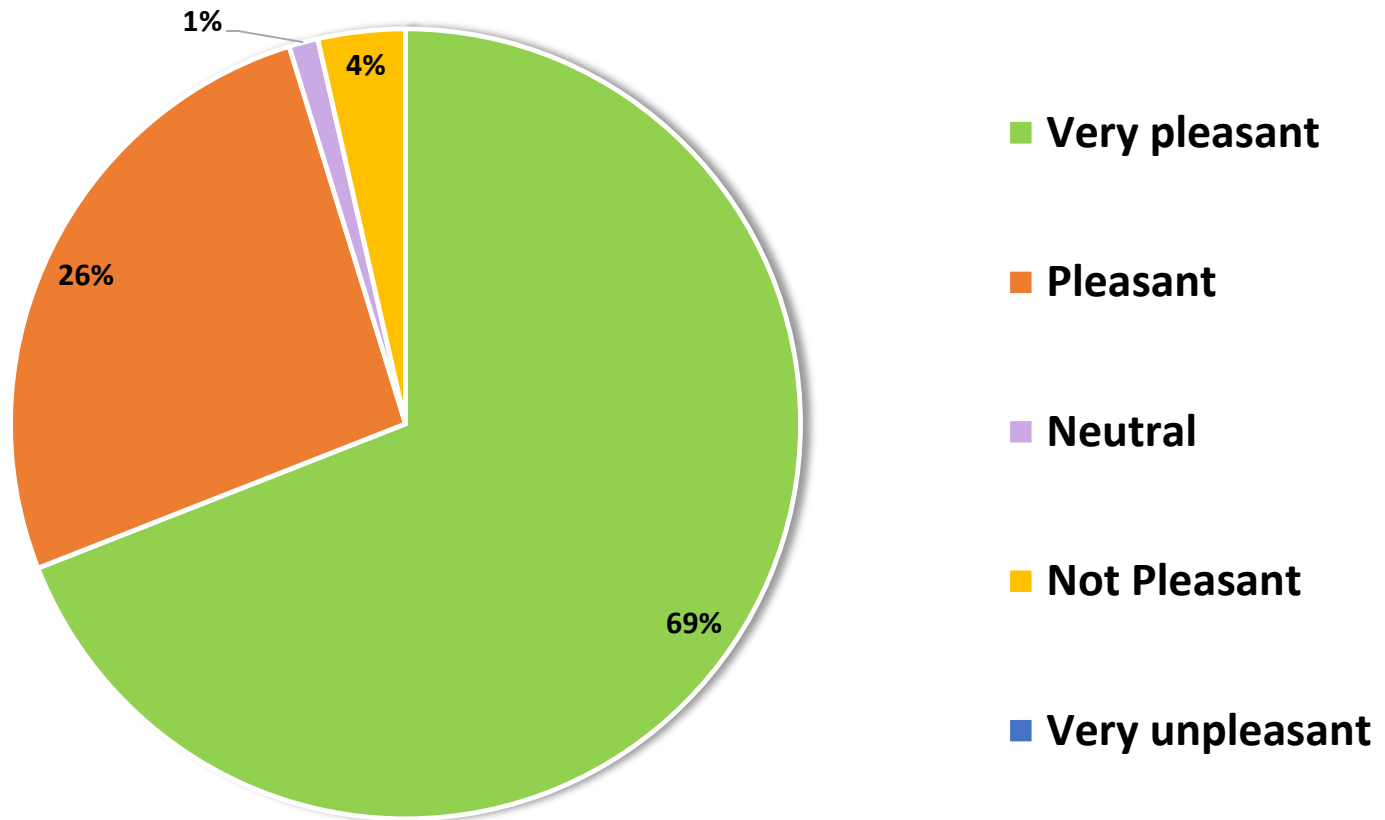

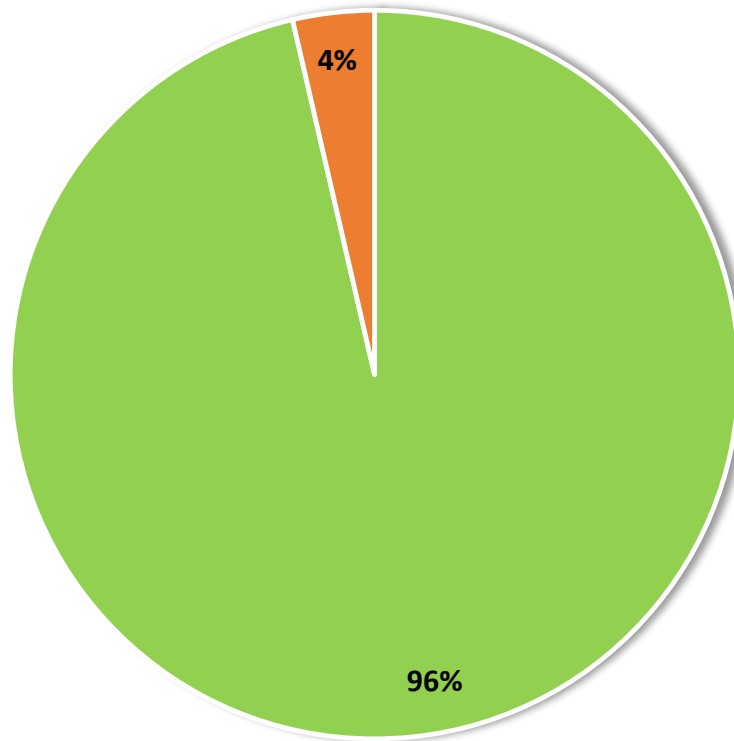

They kept the flow of voter moving along even though we had a number of provisional ballots.

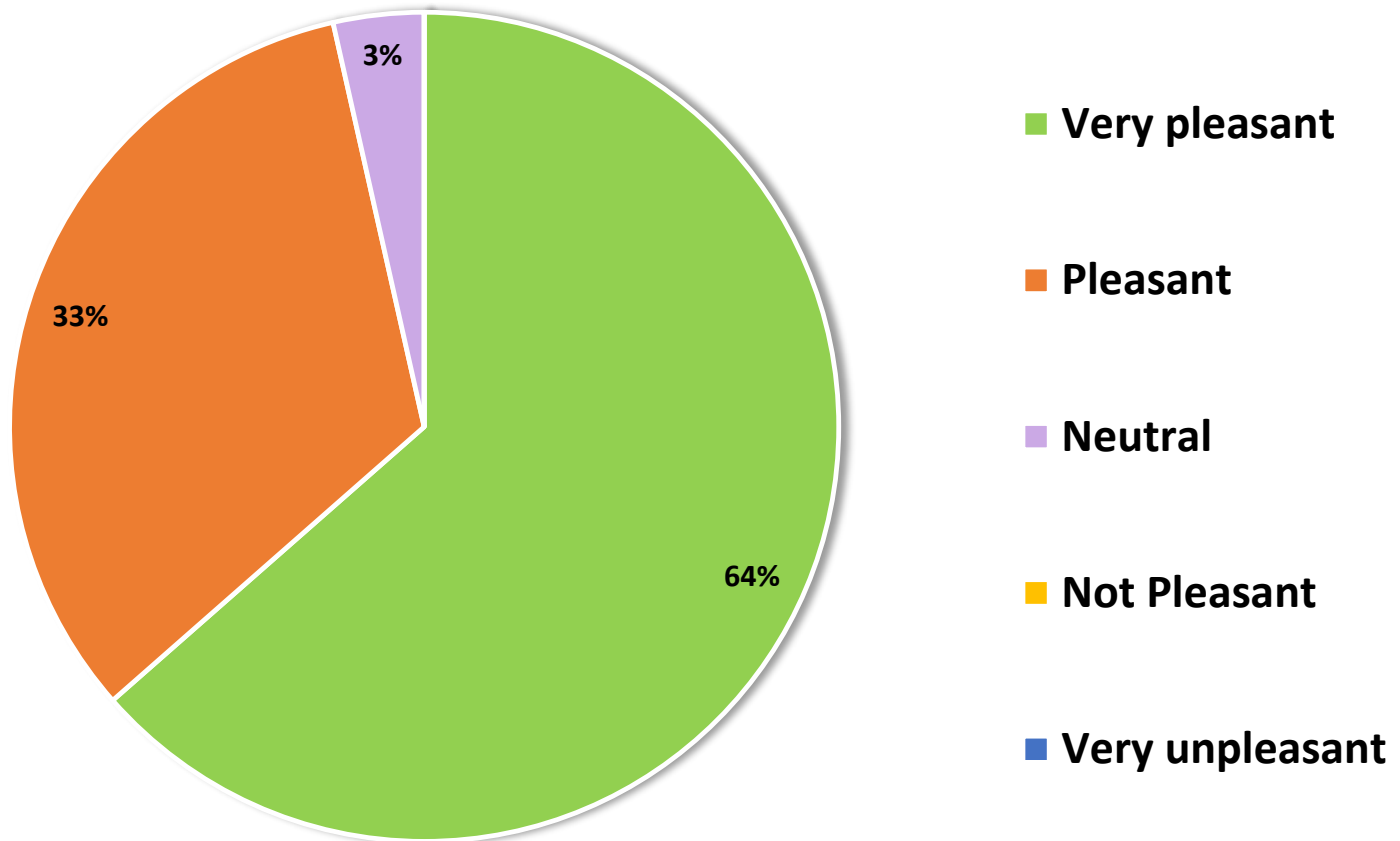
I worked with the best. It makes a big difference.

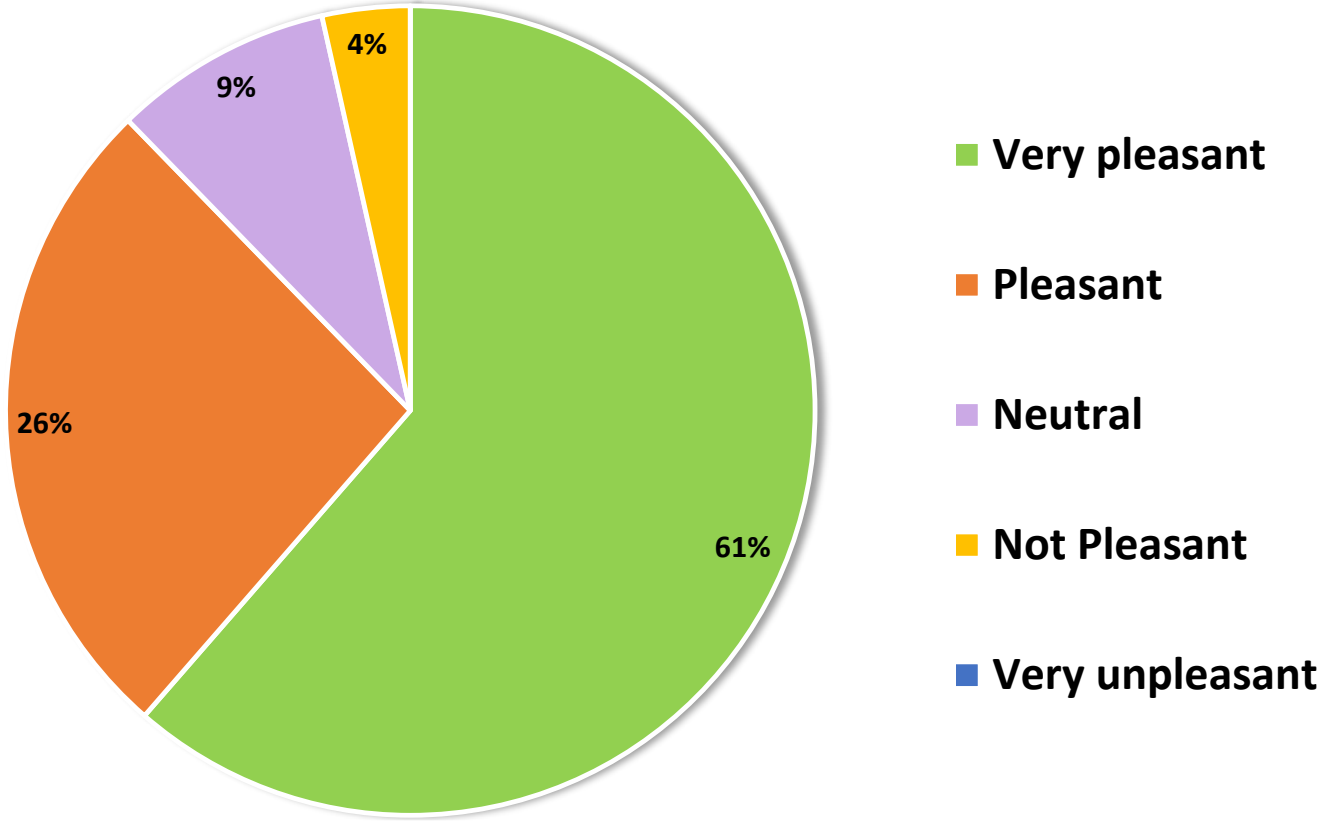

Split up the husband-wife teams.	Orange

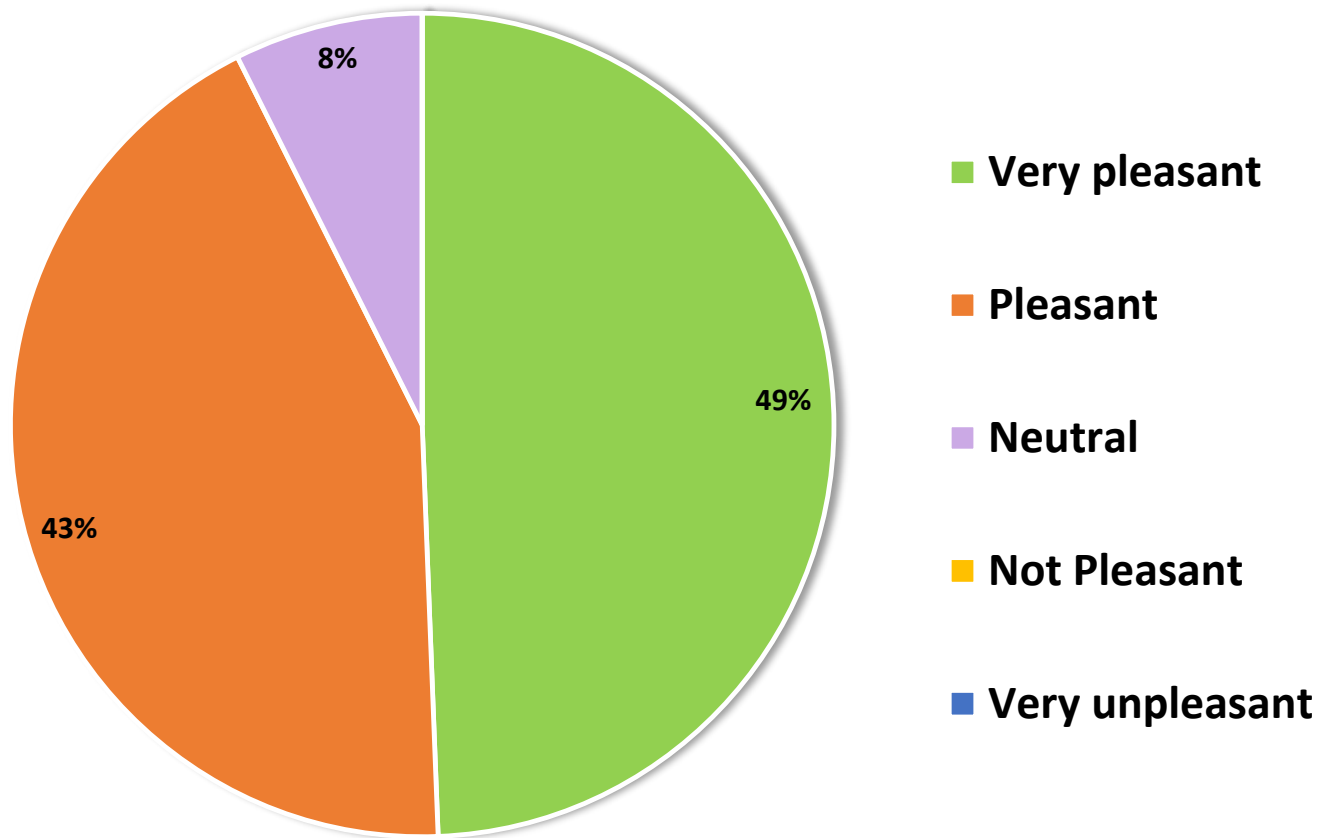

Not jamming the ballot in the slot not folding the printed ballot and not trying to leave with printed ballot in hand. Definitely more time on the "paperwork" relating to ballot inventory accounting.

The hands on provisional exercises we did a while back were helpful a review would be beneficial.

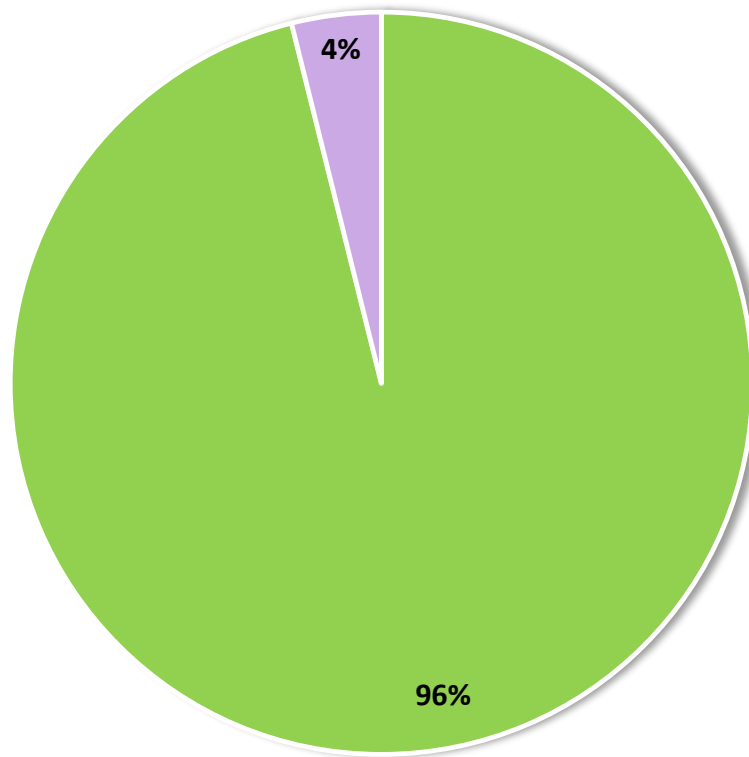
Need more training on tearing down the scanner stand.

They were all helpful. I enjoyed the time.

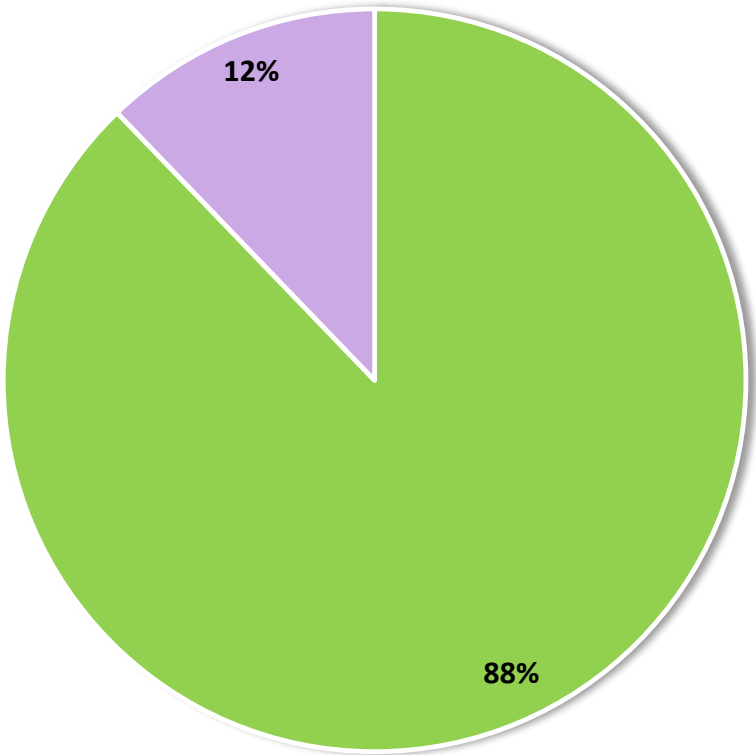
The entire experience was educational. I would like to be considered to work at any election.

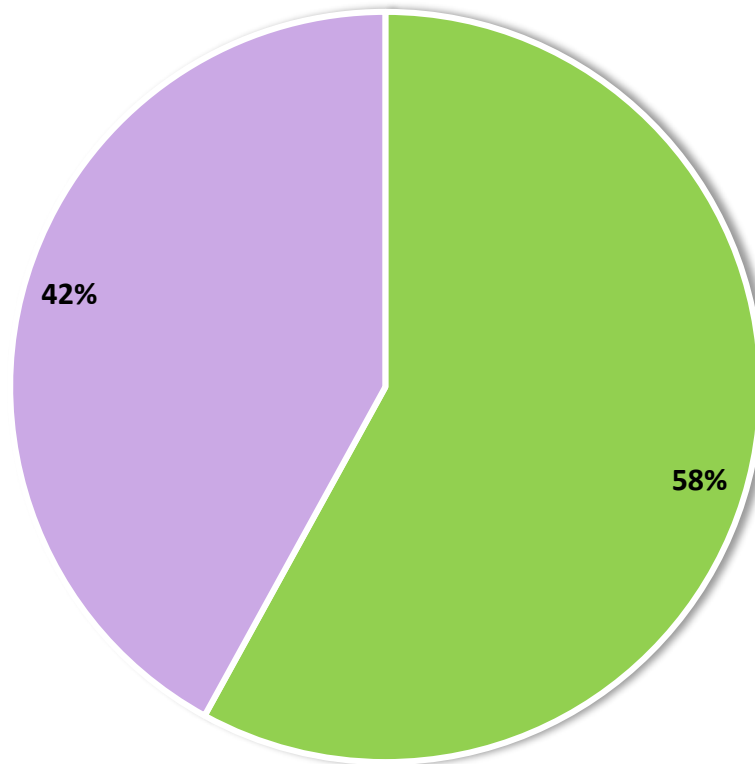


# Overall do you think you had enough Voting machines for the November 2022 Election?

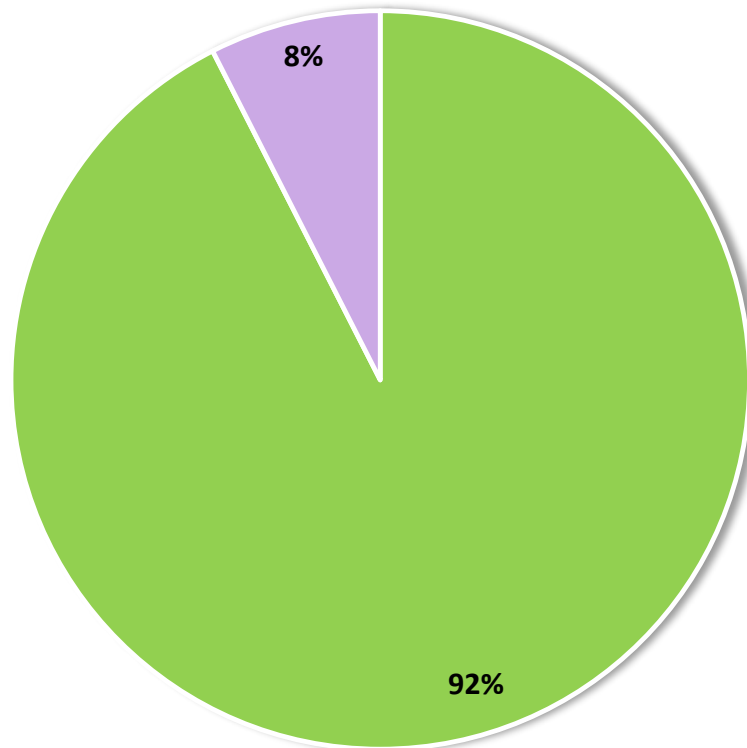
# Overall do you think you had enough laptops for the November 2022 Election?

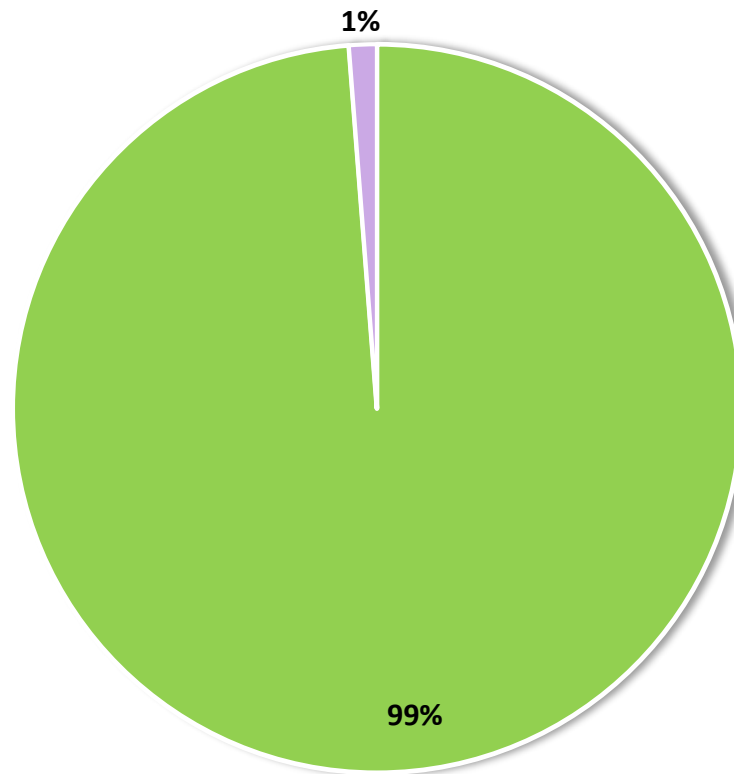


# Do you believe your polling site was well organized?

Our team worked very well together. Have never had a problem.

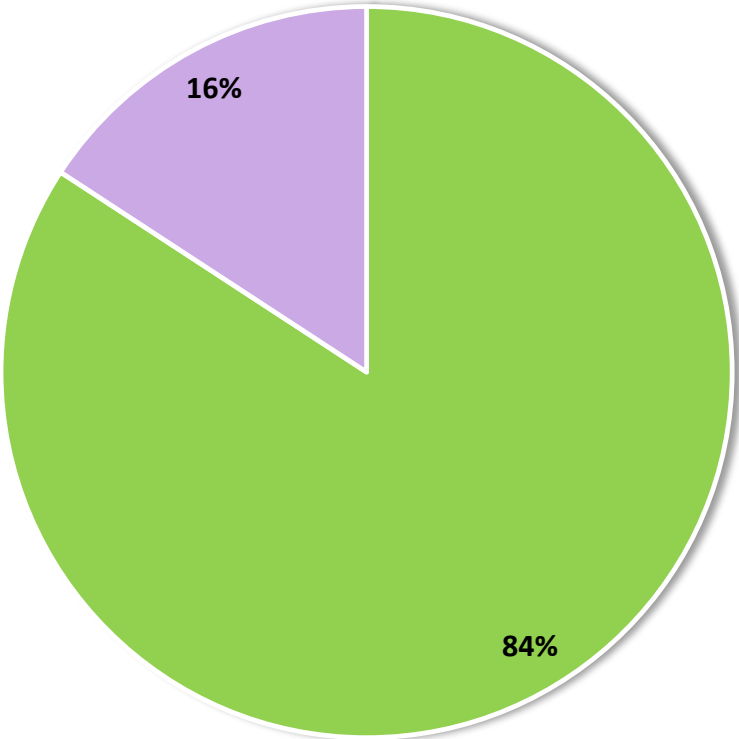
No problem. All worked well together. With 2 new clerks they handled the laptops well, while handling other issues.

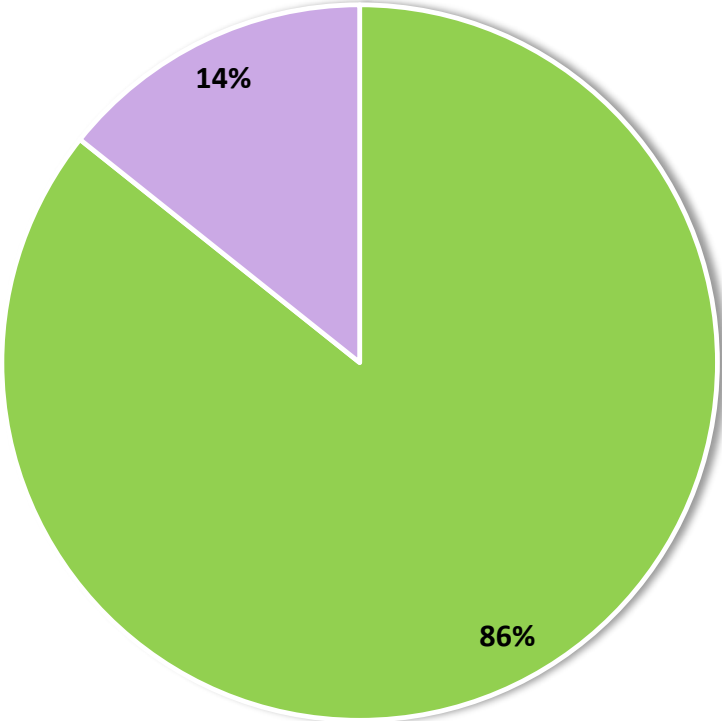

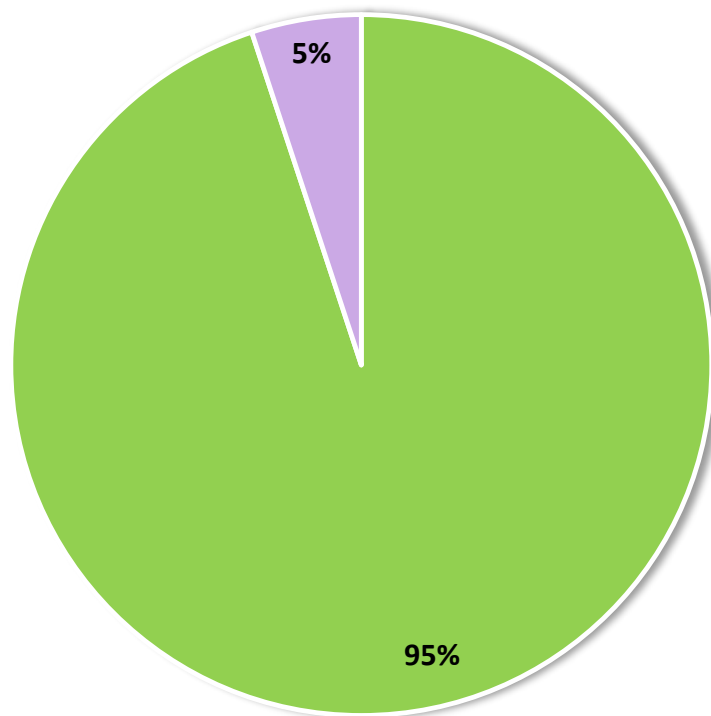
