

## **RESOLUTION**

**A RESOLUTION OF THE LUBBOCK COUNTY, TEXAS, COMMISSIONERS COURT AUTHORIZING THE COUNTY JUDGE OF LUBBOCK COUNTY, TEXAS, OR HIS DESIGNEE, TO ENTER INTO MULTIPLE-USE AGREEMENTS WITH THE TEXAS DEPARTMENT OF TRANSPORTATION, ABILENE DIVISION, AMARILLO DIVISION, CHILDRESS DIVISION, AND LUBBOCK DIVISION, ALLOWING THE INSTALLATION AND OPERATION OF AUTOMATED LICENSE PLATE RECOGNITION CAMERAS IN TEXAS DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, The Lubbock County Commissioners Court has determined that the addition of Automatic License Plate Recognition (ALPR) cameras will increase public safety and aid the South Plains Auto Theft Task Force in its crime prevention efforts and strategies; and

**WHEREAS**, The County Commissioners desire to engage with the Texas Department of Transportation (TxDOT), Abilene Division, Amarillo Division, Childress Division, and Lubbock Division, and asks that Flock safety be allowed to place ALPR cameras in the TxDOT right-of-way on behalf of the South Plains Auto Theft Task Force; and

**WHEREAS**, the County Commissioners find it to be in the public interest to authorize the County Judge of Lubbock County, Texas, or his designee to sign a Multiple-Use Agreement with TxDOT, Abilene Division, Amarillo Division, Childress Division, and Lubbock Division.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSIONERS OF LUBBOCK COUNTY, TEXAS, THAT:**

Section 1. The County hereby authorizes the County Judge of Lubbock County, Texas, or his designee, to enter into a Multiple-Use Agreement with TxDOT, Abilene Division, Amarillo Division, Childress Division, and Lubbock Division for the installation and operation of ALPR cameras in the TxDOT right-of-way.

Section 2. This Resolution shall take effect immediately upon adoption.
