THAT the County Judge of Lubbock County, Texas is hereby authorized and directed to accept for and on behalf of the County of Lubbock one certain Street and Public Use Dedication Deed (the "Dedication Deed") in connection with a 0.108 acre parcel located in Section 26, Block 20, Lubbock County, Texas, being a portion of 1.091 acres described in County Clerk File Number 2010005750, Official Property Records, Lubbock County, Texas ("Parcel 164") to be utilized for the roadway expansion project, commonly known as the "Woodrow Road Project," and all related documents. Further, the County Judge of Lubbock County, Texas is hereby authorized and directed to authorize and make payment in the amount of \$47,024.42 as consideration for the acquisition of the Dedication Deed at the closing of Parcel 164. Said Dedication Deed is attached hereto and incorporated in this Resolution as if fully set forth herein and shall be included in the minutes of this Commissioner's Court.

RE: Discussion of Right-of-Way Acquisition Costs for the Woodrow Road Project, Parcel 164, Eric L. Buske and Haley A. Buske

Lubbock County is acquiring the necessary right-of-way and easements for Woodrow Road from FM 1730 (Slide Road) to SL 493. The cost for the Street and Public Use Dedication Deed for Parcel 164, Eric L. Buske and Haley A. Buske is \$47,024.42, with estimated closing costs in the amount of \$899.88 (+/- 20%) for a total estimated acquisition cost of \$47,924.30.

Funding for this acquisition is as follows:
\$47,924.30 to come from Woodrow Road, Auditor #B11003.
