The FY 2026 Lubbock County Salary Grievance Committee meeting was called to order at 2:00 p.m. by presiding officer County Judge Curtis Parrish.

Presentation was made to the committee by Lubbock County Sheriff Kelly Rowe.

Presentation was made to the committee by Justice of the Peace Pct. 2 Susan Rowley.

A motion was made by Joel Scott, seconded by Stetson Smitherman and the committee voted Nine for and Zero against to increase the salary of Sheriff Kelly Rowe to \$150,000.00. Per Local Government Code, section 152.014 this approval is automatic.

A motion was made by Nikki Tafoya, seconded by Karen Hatley and the committee voted Seven for and Two against the increase of the salary of Justice of the Peace Pct. 2 Susan Rowley to \$100,686.00. Per Local Government Code, section 152.014 this recommendation will be made to the Commissioners' Court for further consideration.
