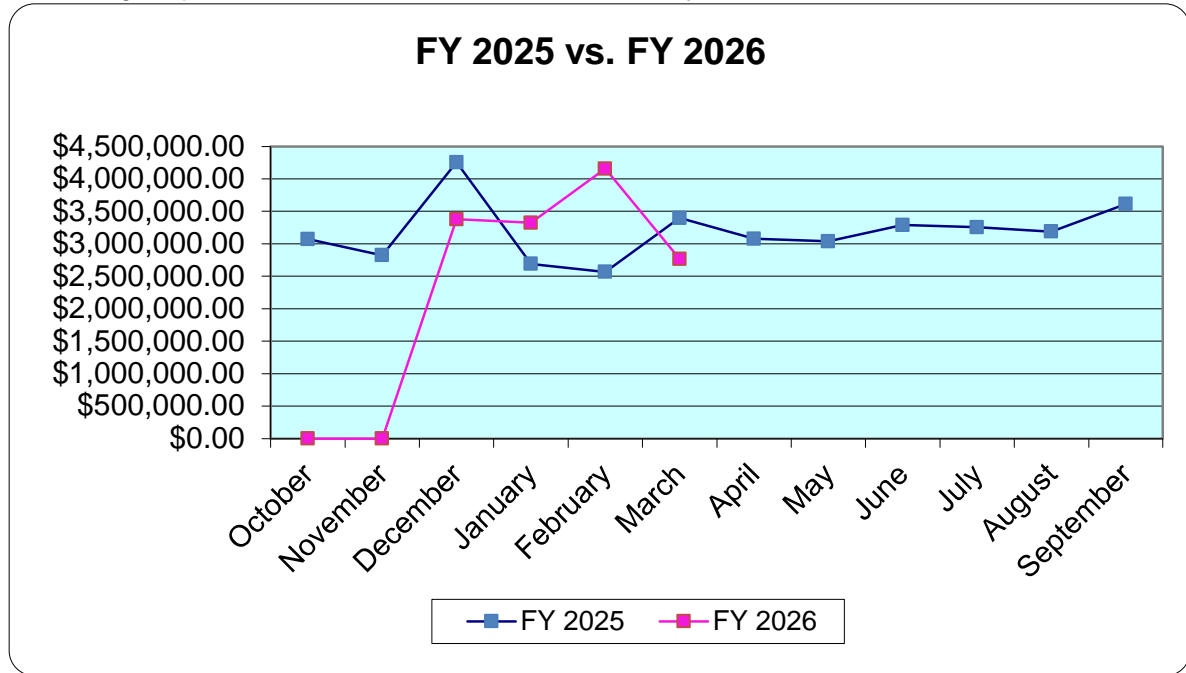

 As of March 2026

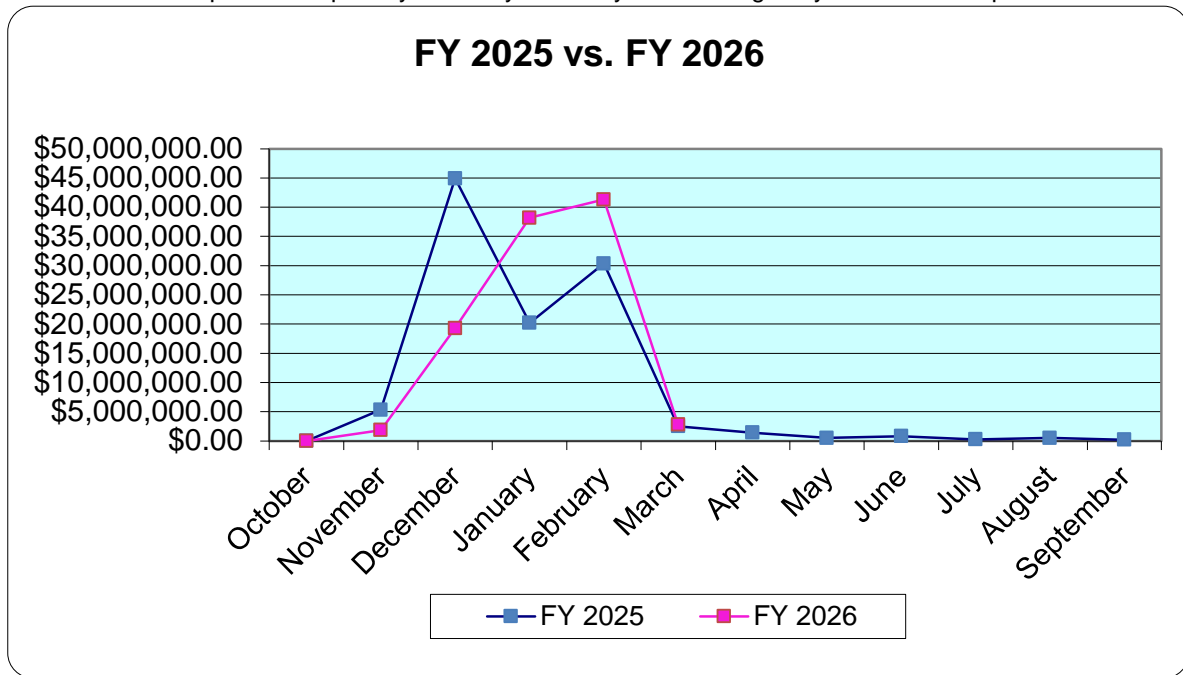
