ORDER OF THE DISTRICT JUDGES OF LUBBOCK COUNTY, TEXAS

Approving Assistant County Auditor Appointments and Salaries and

Lubbock County, Texas

Certifying Same to the Commissioners Court (Local Government Code §§ 84.021 & 152.905)

WHEREAS, on September 12, 2025, the undersigned district judges held a public hearing on the annual compensation of the County Auditor, Assistant Auditors, and official court reporters, after notice was published in the Lubbock Avalanche Journal on August 29, 2025, which was not earlier than the 30th day before the hearing and not later than the 10th day before the hearing, with opportunity for interested persons to be heard.

AND WHEREAS, the County Auditor certified to the district judges a list of assistant auditor positions and appointees stating, for each appointee, the name, position, duties (by job description), and qualifications/experience; salaries for these positions were set within the FY26 budget process by the Lubbock County Commissioner's Court and totaled \$12,405.100; that certified list, titled "Application for Appointment of the Assistant Auditors," is incorporated by reference as Exhibit A.

AND WHEREAS, after inquiry into the qualifications, experience, and reasonableness of the proposed compensation for each appointee, the district judges approve the appointments and compensation as reflected by position in Exhibit A and the adopted FY26 salaries. (Tex. Loc. Gov't Code § 84.021.)

IT IS THEREFORE ORDERED:

- A. Approval of Appointments and Salaries. The persons identified in Exhibit A are to be appointed as assistant county auditors for Lubbock County, Texas, in the positions listed, with the duties stated in their job descriptions and compensation set by the adopted FY26 county budget for each appointee, effective October 1. 2025 (FY26), subject to lawful budget appropriation and employment onboarding requirements. The aggregate amount for the Auditor's Office was set by the Commissioner's Court within the FY26 budget process and totals \$12,405.100.
- B. Certification to Commissioners Court. Pursuant to Tex. Loc. Gov't Code § 84.021, the undersigned judges hereby certify the approved list of assistant auditors and the compensation for each as determined by the adopted FY26 county budget, which, for the Auditor's Office, totals \$12,405,100 as set by the Commissioner's Court. The Lubbock County Commissioner's Court shall order the compensation to be paid upon performance of services and shall appropriate an adequate amount of money for this purpose.
- C. Record of Action. The District Clerk (or Court Administrator, as applicable) shall maintain this Order with Exhibit A in the court's administrative records.
