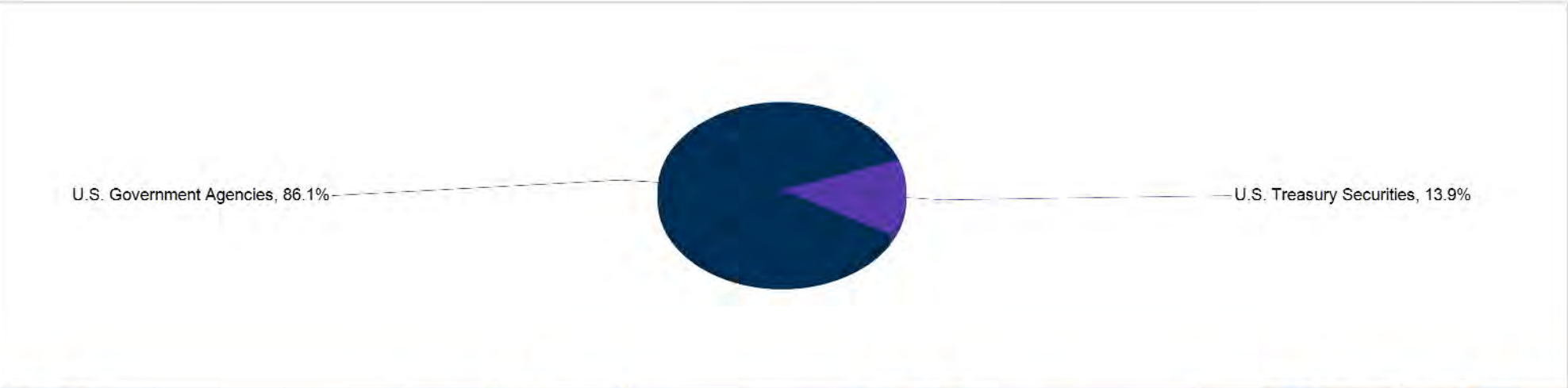

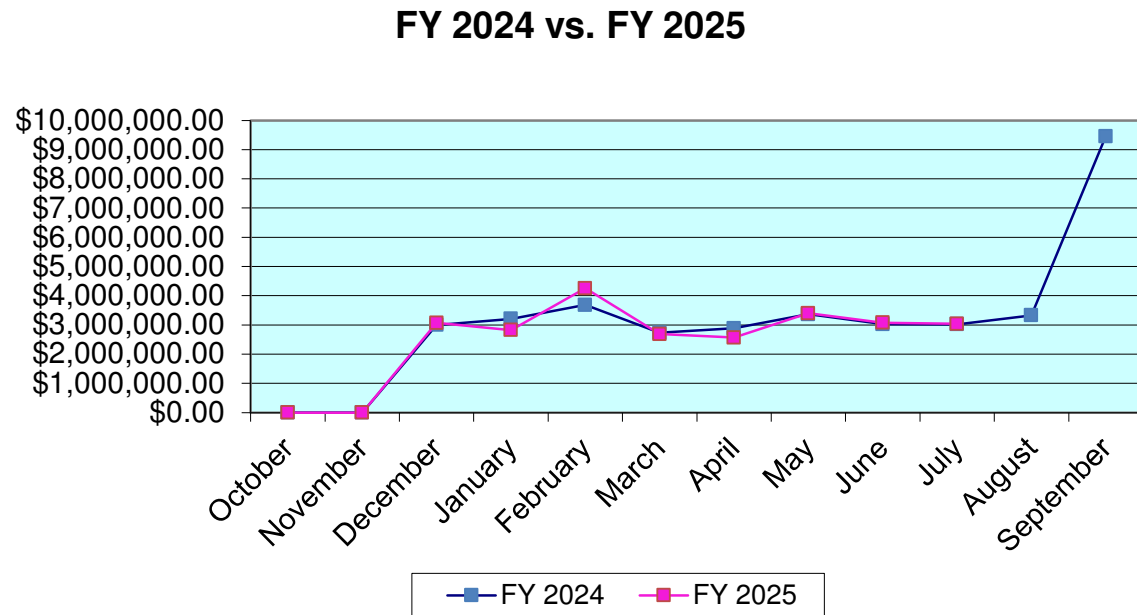

As of July 2025

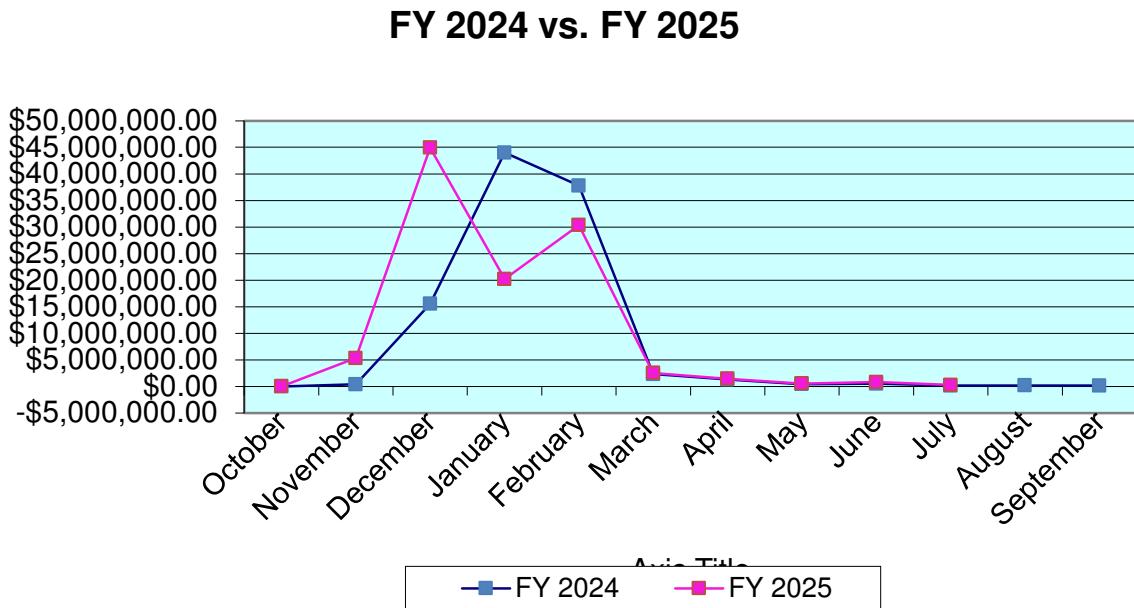
