Dear Lubbock County Commissioners:

As Chair of the Lubbock County Historical Commission, I respectfully submit the following names for appointment to the Lubbock County Historical Commission for the 2023-2024 term. Chapter 318 of the Texas Local Government Code directs you to make appointments by December 31. The statute does not provide for a set number of members and the LCHC By-laws state that the outgoing Commission Chairperson should advise the County Commissioners' Court on this point at the time appointments are made. As outgoing LCHC Chair, I recommend that 18 members be appointed, which is the roster number outlined in the bylaws and maintained for the past decade. In addition, I have agreed, if so desired, to continue another term as Chair. Cameron Saffell requests that he continue as Historic Preservation Officer

- Attend Commission meetings, programs, and activities, including marker dedication ceremonies;
- Serve and actively participate on one or more LCHC committees;
- Record at least fifty (50) hours of volunteer service each calendar year performing the above activities; and,
- Submit summary information of activities and hours of service to the LCHC Chairperson for inclusion in the Commission's annual report.

Lubbock County Historical Commission is an active organization, relying on its members to fulfill our mission of preserving and promoting the history of Lubbock County. Our members logged over 3,000 volunteer hours in 2021. For the 14th consecutive year, the Texas Historical Commission recognized LCHC with its Distinguished Service Award for the 2021 year of service. These accomplishments are all dependent on dedicated members. I believe this list of recommended appointees will allow LCHC to continue accomplishing the goals we have set.
