Cremation Authorization Certificate AKA Cremation Authorization Letter	\$25 Each	<i>Code of Criminal Procedure, Art. 49.25 §§ 13A: FEES; Art. 49.25, Sec. 10 Disinterment and Cremations</i>	<i>In Texas, the Texas Code of Criminal Procedure (CCP) Chapter 49, Article 49.25, Section 10, covers disinterment and cremation. This section mandates that before anyone can be lawfully cremated, the owner or operator of the crematory must be furnished with a certificate (letter) signed by the medical examiner of the county in which the death occurred. The certificate (letter) must indicate whether an autopsy was performed or was deemed unnecessary based on the circumstances surrounding the death. The medical examiner is responsible for determining if an autopsy is required and for issuing the necessary certificate (letter) to the crematory.</i>

Requests to hold specimens past the two-year retention period must be submitted on letterhead yearly. (See Retention Policy).</i>
Body Hold Storage Fee	\$75/Day Starting on Day 6	<i>Code of Criminal Procedure, Art. 49.25 § 13A: FEES</i>	<i>Approved by the Lubbock County Commissioner's Court on 12/27/2021, with an effective date of 02/01/2022.</i>
