POWER OF ATTORNEY

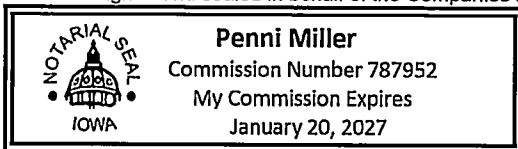

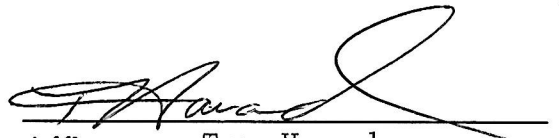
