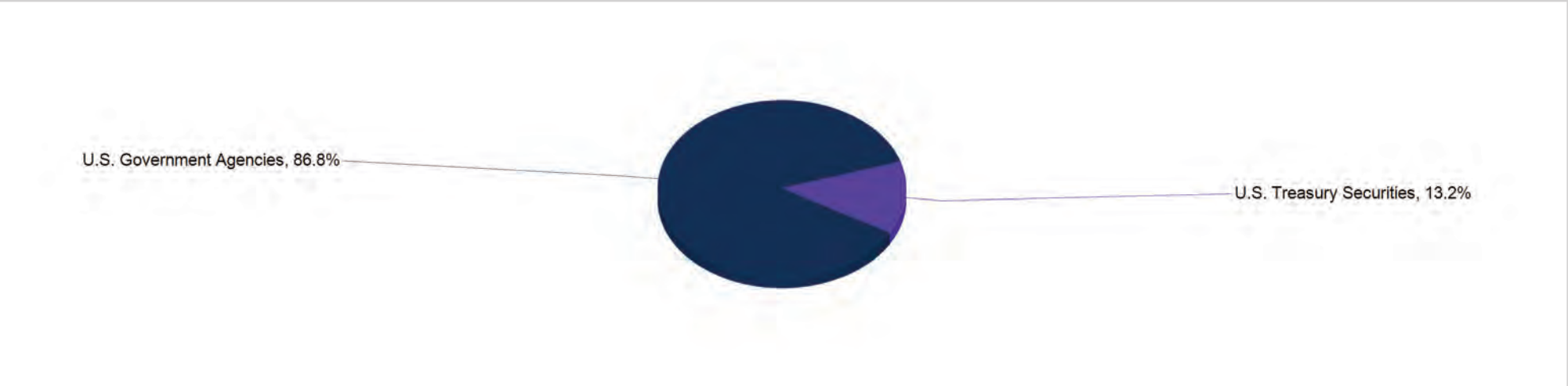

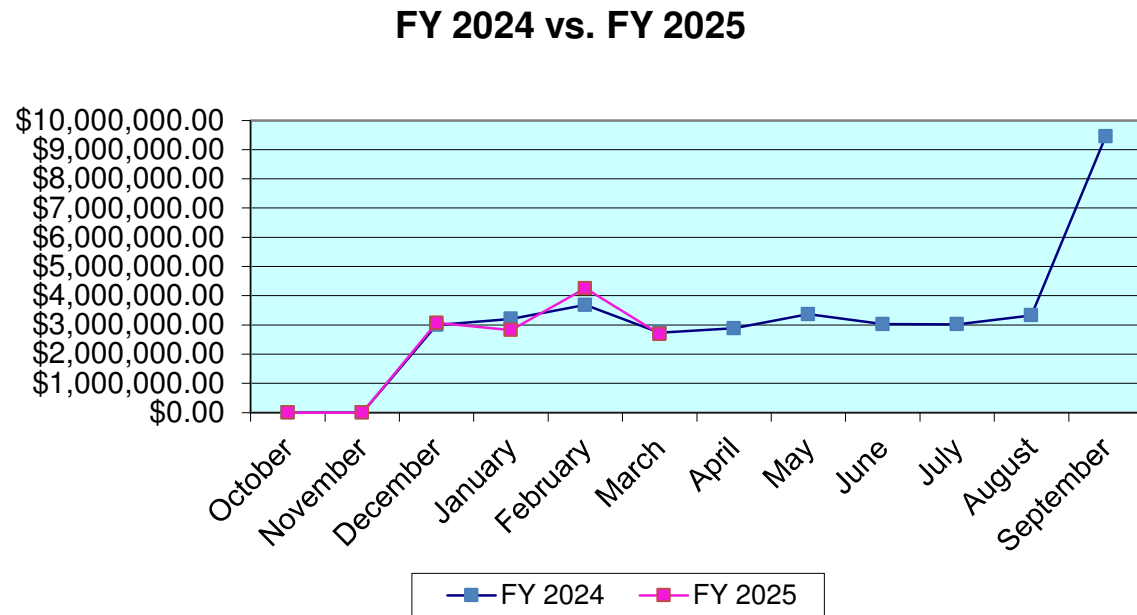

As of March 2025

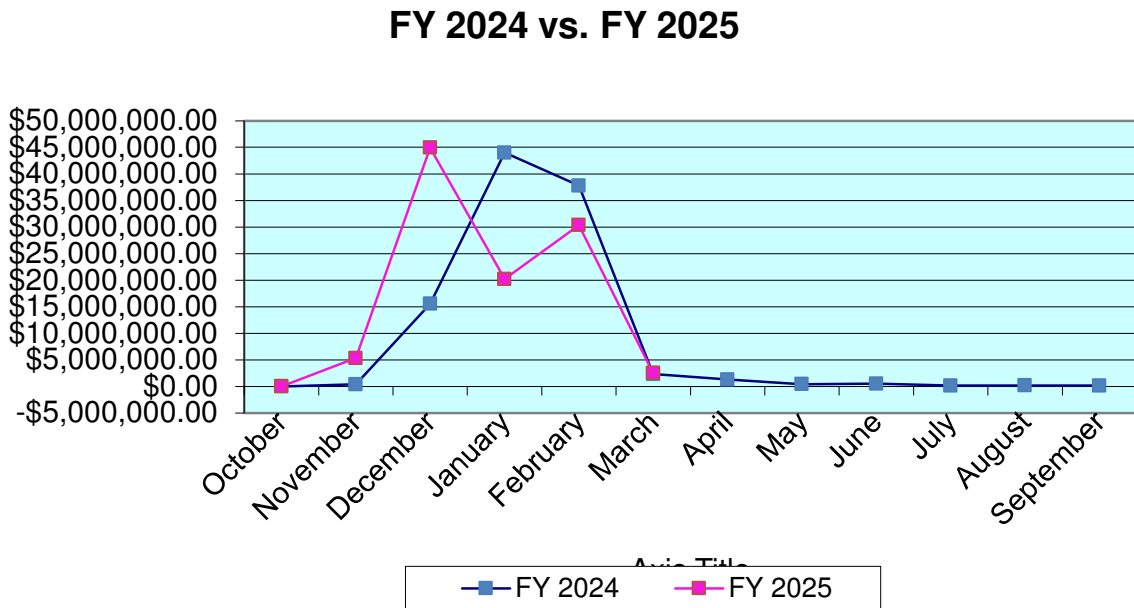
