Re: Travel to St. Augustine, Florida

When purchasing an armored Rook through Ring Power Corporation, one of the requirements is to go to the manufacturing location, toward the completion of the vehicle being purchased. This is for inspection of their facilities, the vehicle being purchased and a walk through of the vehicle's capabilities to have a full understanding of the operational concept. This travel includes two days of travel, paid for by Ring Power, and one full day at their facilities. Ring Power also pays for lodging.

The trip has been planned for December 11 through December 13, 2023. The flights and hotel have already been set up and paid for by Ring Power for SSgt. Siegfried and Lt. Daniel. This will be at the completion of the armored Rook, just prior to it being ready for shipment.

Lubbock County will only need to provide funding for a rental car and per diem.
