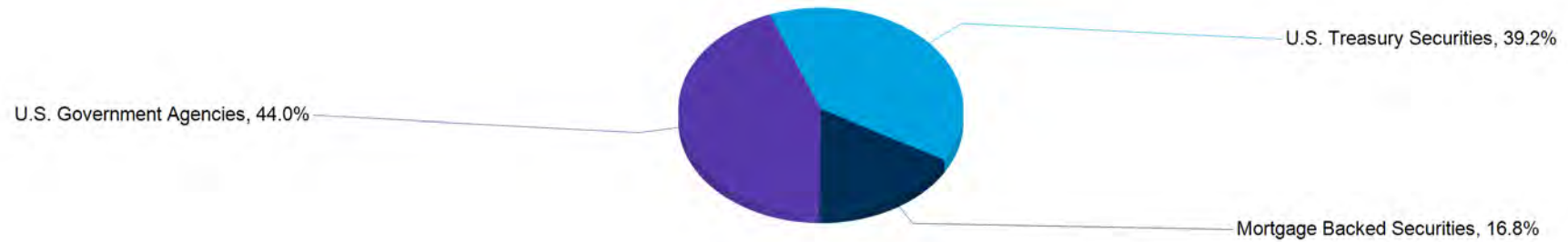

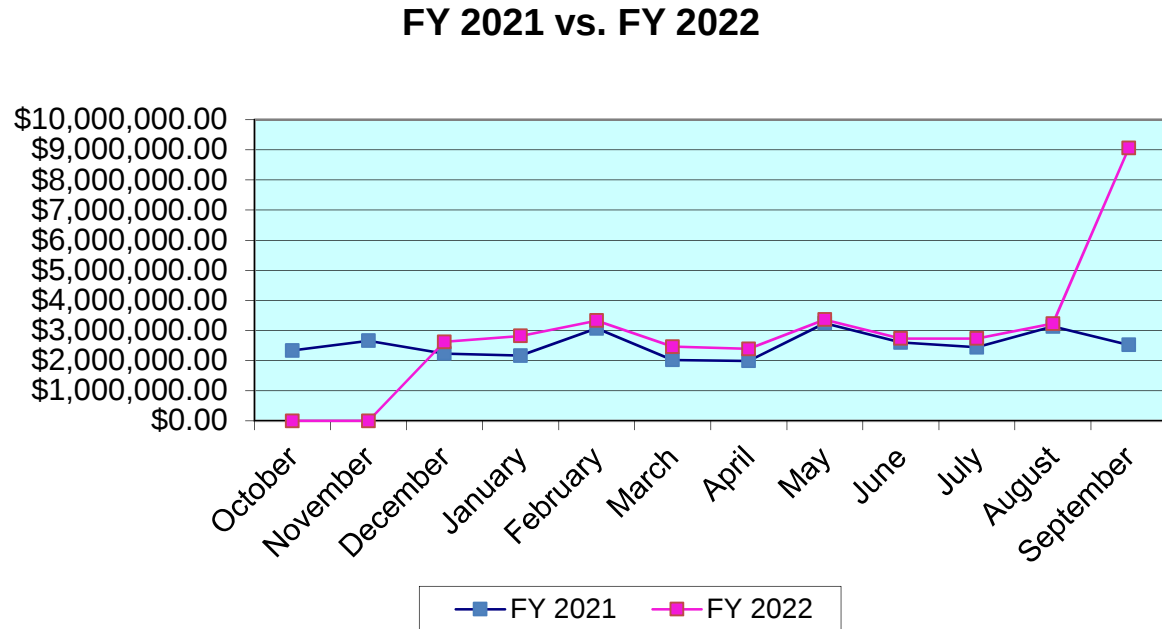

As of September 2022

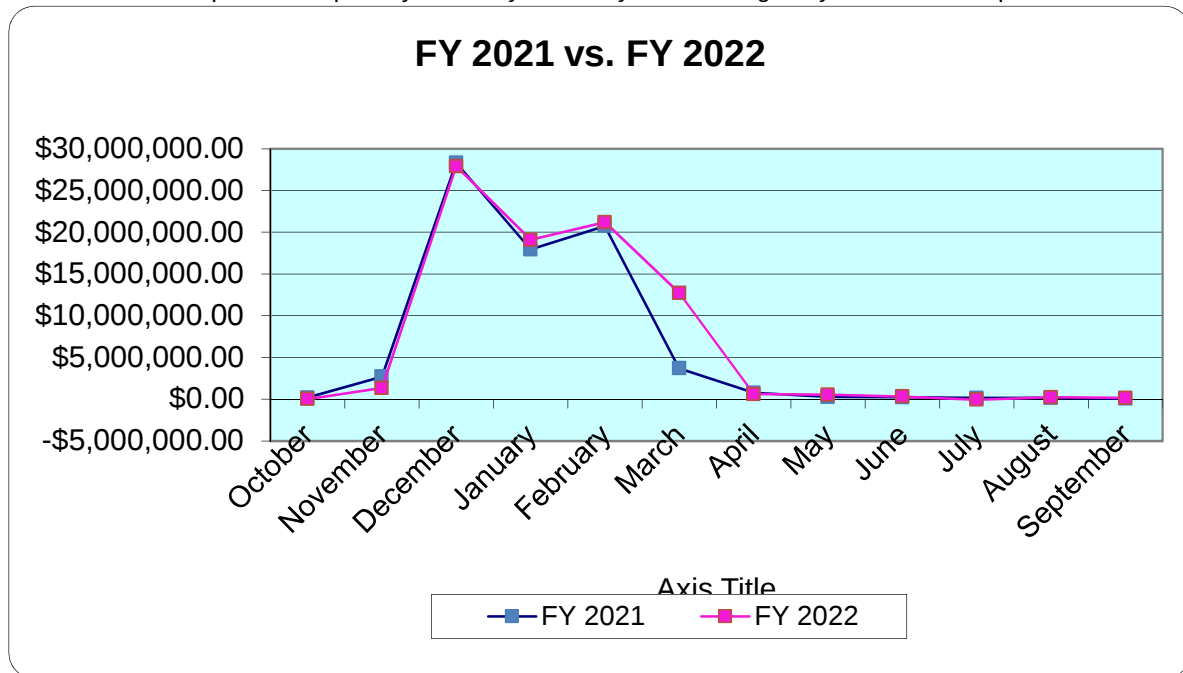
