Further, the County Judge of Lubbock County, Texas is hereby authorized and directed to authorize and make payment in the amount of \$1,432.00 as consideration for the acquisition of the Dedication Deed at the closing of Parcels 84 and 84-A. **RE:** Discussion of Right-of-Way Acquisition Costs for the Woodrow Road Project, Parcel 84 and 84-A, Tim Green Homes, Inc.

Lubbock County is acquiring the necessary right-of-way and easements for Woodrow Road from FM 1730 (Slide Road) to SL 493. The cost for the Street and Public Use Dedication Deed for Parcel 84 and 84-A, Tim Green Homes, Inc., is \$1,432.00, with estimated closing costs in the amount of \$749.88 (+/- 20%) for a total estimated acquisition cost of \$2,181.88.

Funding for this acquisition is as follows:  
\$2,181.88 to come from Woodrow Road, Auditor #B11003.

Checks in the amount of \$1,432.00 and \$749.88 (+/- 20%) should be made out to Lubbock Abstract & Title Company. Checks should be sent to the following address:
