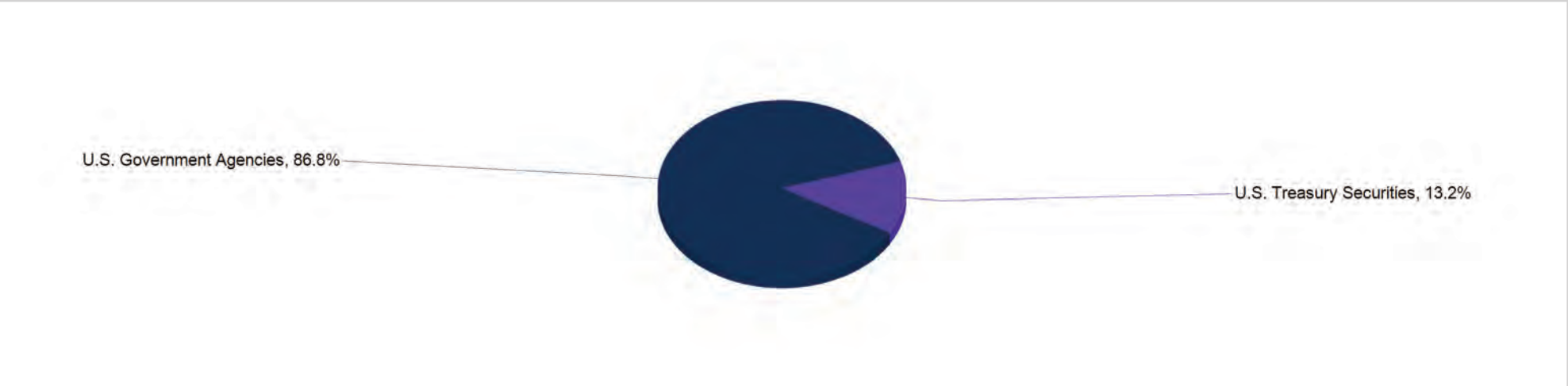

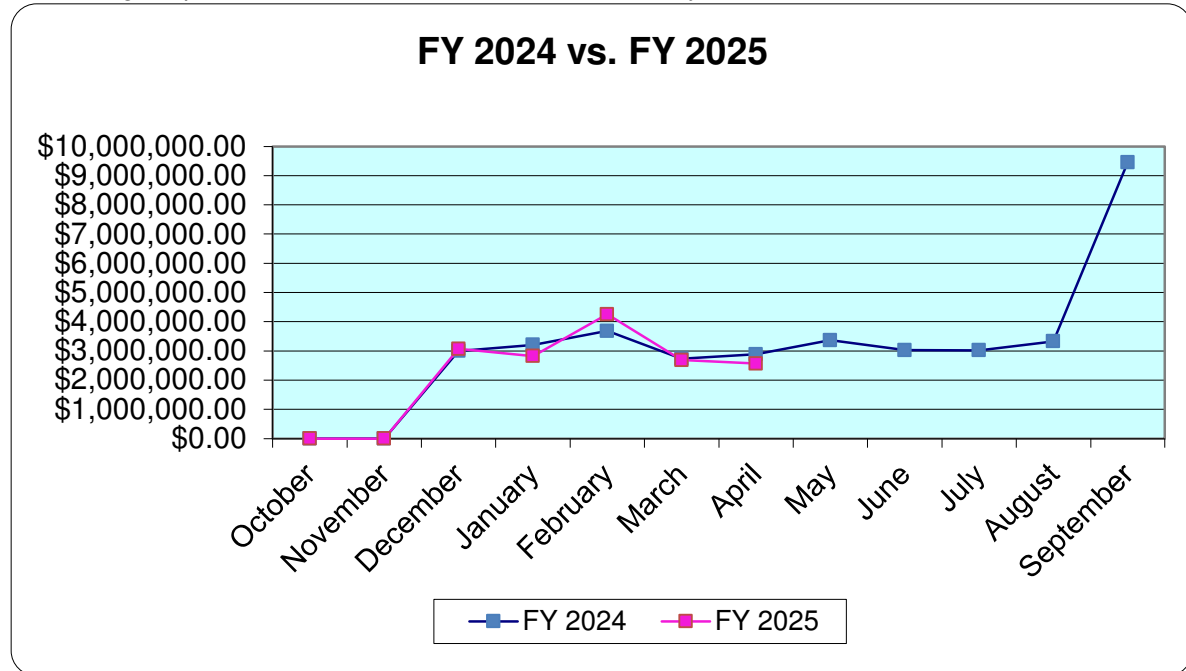

As of April 2025

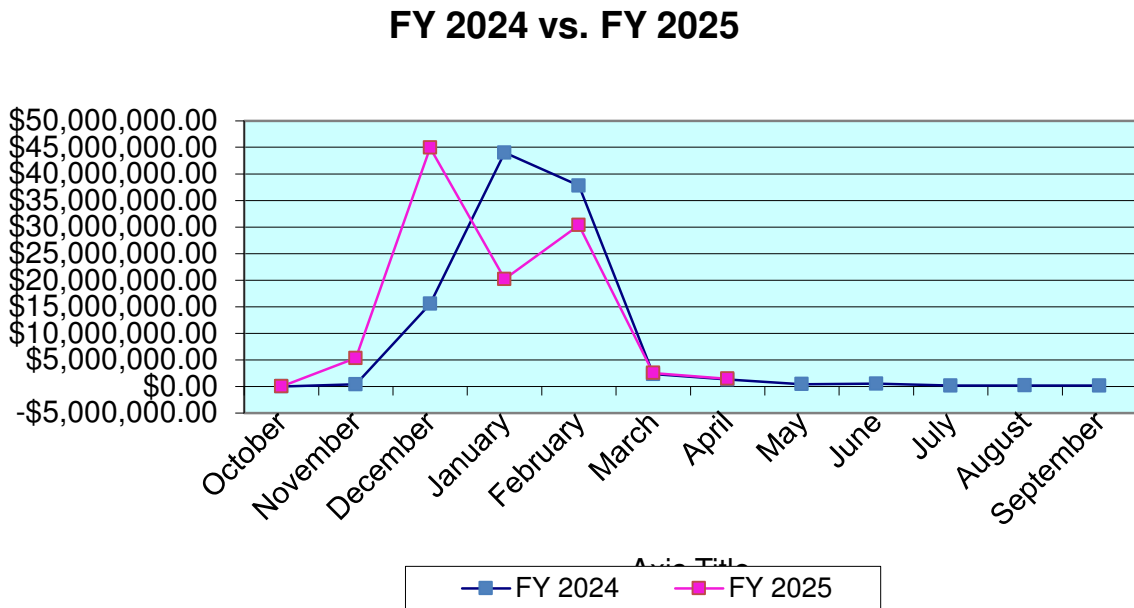
