FY2026 Projected Budget Request

The Lubbock County Medical Examiner's Office respectfully submits the following projection for our FY2026 forensic pathology services budget. This projection is based on trends and actual costs observed throughout FY2025.

The office contracts with Forensic Pathology Staffing (FPS) to perform autopsy services, provide toxicology and histology testing, and offer professional oversight and consulting. The current agreement with FPS is structured as a flat-rate contract of \$118,000 per month, covering up to 600 cases per year. We are not billed per autopsy- the rate remains fixed regardless of case volume up to that number. This revised rate was outlined in the amended agreement and went into effect at the start of FY2025. However, the original FY2025 budget was built using a more conservative estimate to reduce costs, based on the prior year's expenditures and expected needs. While this approach was intended to be fiscally responsible, it ultimately underestimated the actual cost of the updated contract.

In FY2025, the combination of fixed autopsy service costs and variable testing demands has outpaced the original allocation, resulting in a significant shortfall by mid-year. Additionally, the FY2025 budget did not fully anticipate the scale of charges related to toxicology and histology testing, which to date have totaled over \$82,000. These tests are billed in addition to the flat, monthly rate of \$118,000 and can vary depending on case complexity and forensic pathologist. Unexpected costs also rose from the use of locum medicolegal death investigators early in the fiscal year.

Looking ahead, we anticipate continued growth in case volume and potential expansion of services to neighboring counties once the new facility is operational. Due to that, we hope to provide a more accurate and sustainable FY2026 budget proposal.

- Autopsy Services: \$118,000/month x 12 months=\$1,416,000
- Toxicology Testing: \$8,000/month average=\$96,000
- Histology Testing: \$3,200/month average=\$38,400
- Growth Cushion (15 % projected increase) =\$270,000
- TOTAL ESTIMATED NEED=\$1,820,400

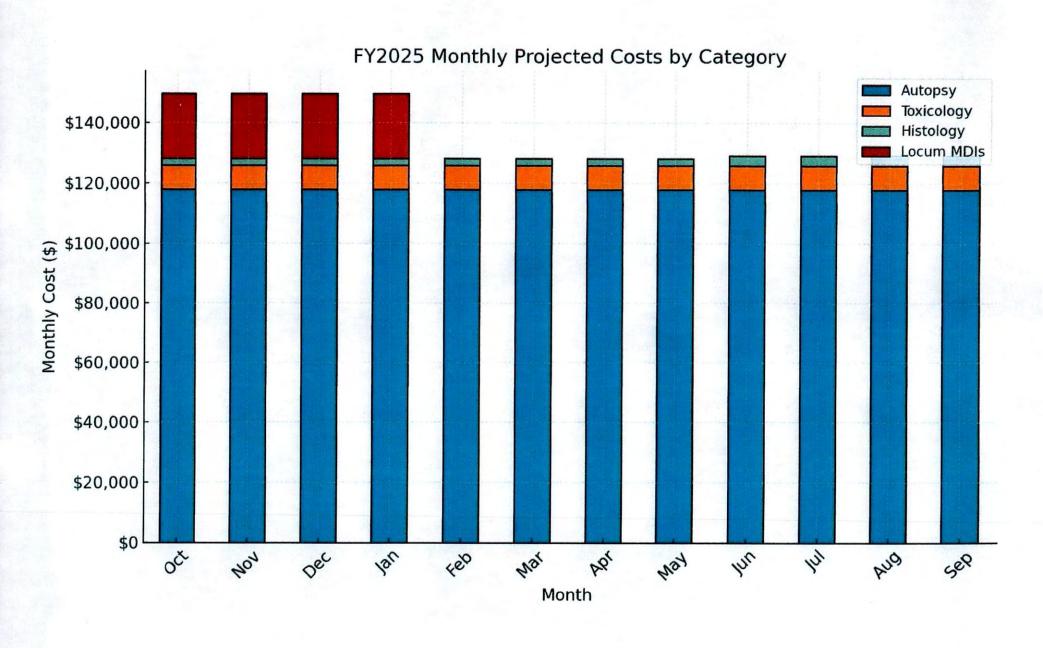

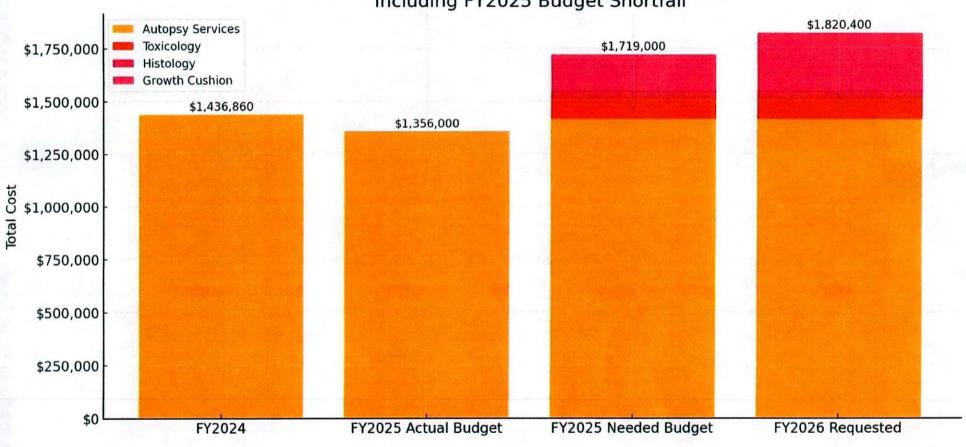

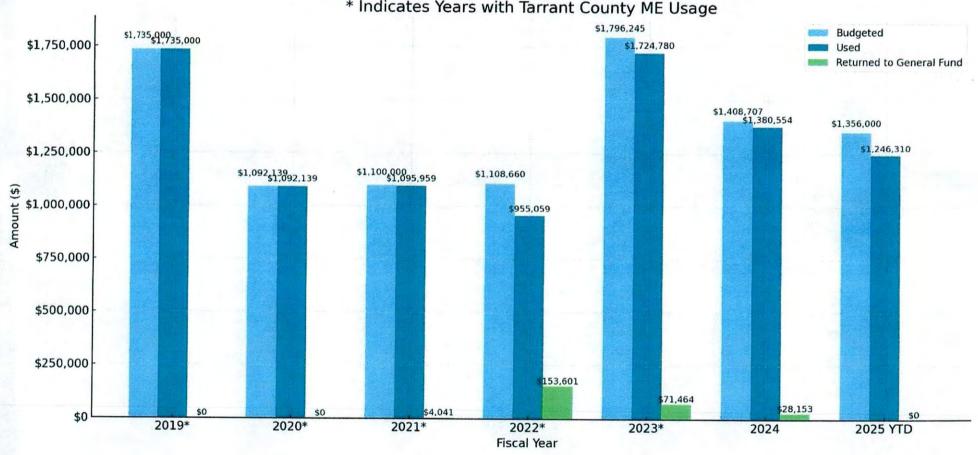

FY25 Budget Justification - Forensic Pathology Staffing

In FY25, the Lubbock County Medical Examiner's Office faced a sudden and complete loss of its full-time Medicolegal Death Investigators. To maintain critical death investigation operations, we immediately relied on contracted locum investigators. While this came at a higher cost than regular staffing, it prevented operational disruption, ensured continuity of service, and allowed time to interview and train new staff.

Locum Investigator Cost Breakdown (Oct-Mar)

Out of the total \$158,781.00 spent on locum investigator support from October through March, \$76,317.50 was attributed directly to hourly wages. The remaining \$82,463.50 covered necessary non-salary expenses, including travel and lodging. No per diem was provided. These non-salary expenses consisted of the following:

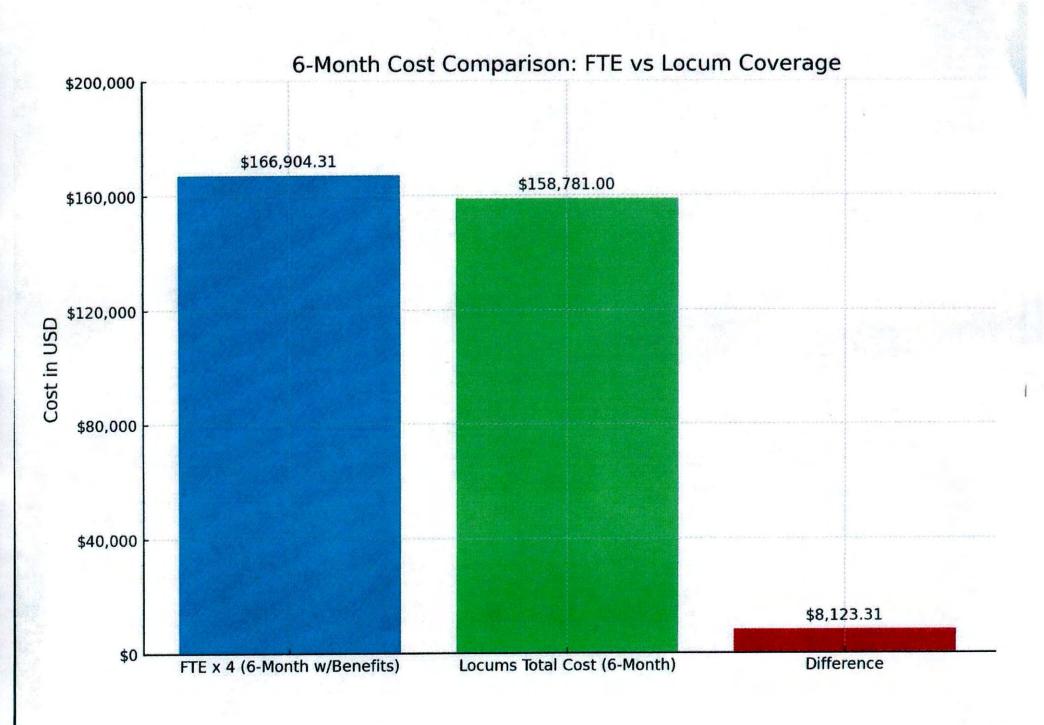
- Flights to and from Lubbock
- Hotel accommodations
- Ground transportation (rental cars, mileage reimbursements)
- Flat-rate payments are made to locum investigators for being available after hours and on weekends—even if they weren't called out. This was part of the staffing contract.

Visual Comparison

Visual Breakdown: FTE Salaries vs. Locum Costs (Oct-Mar)

This breakdown highlights how nearly half the locum expense was for travel-related needs—costs that would not exist under regular full-time employment. Locum investigator coverage ended in March 2025 after full-time investigators were successfully hired. The remaining expected expenses for June through September of FY25—estimated at \$130,000 per month—are tied to ongoing autopsy services, histology testing, and consultation services provided through our forensic pathology contract. This justification demonstrates that the funds were used appropriately and strategically to uphold our mission.

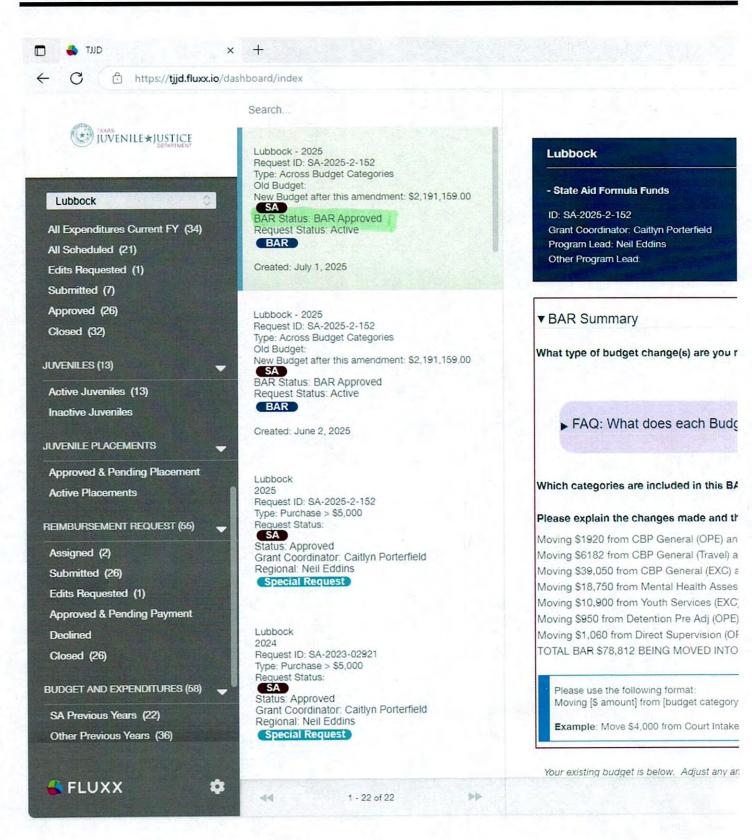

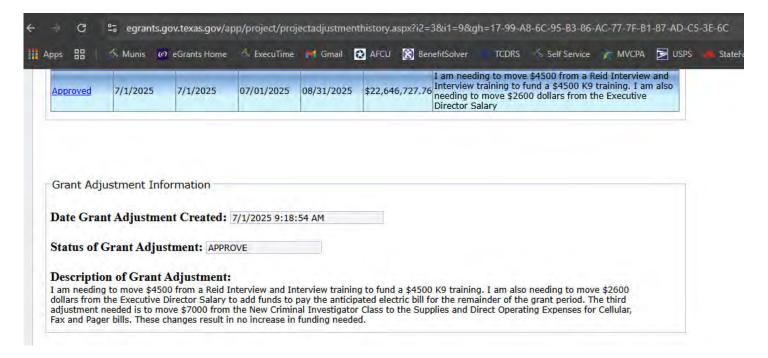
