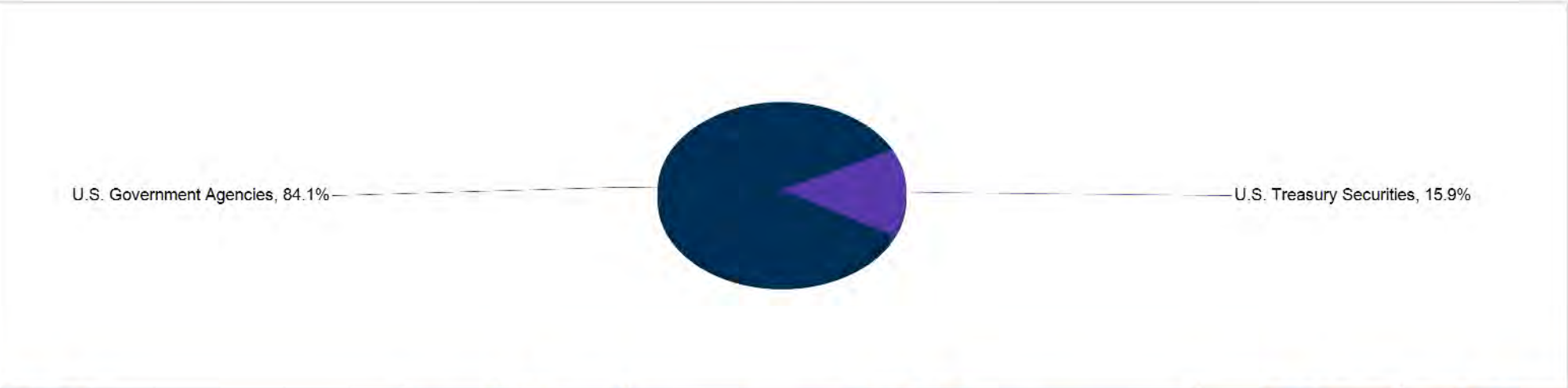

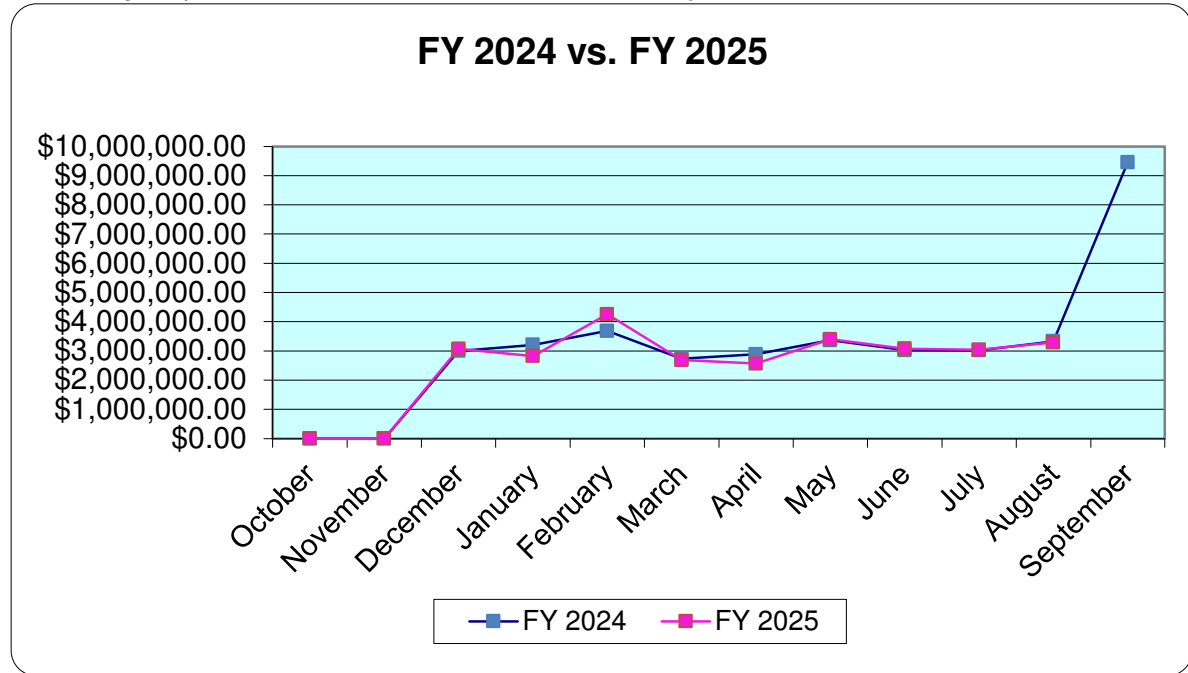

As of August 2025

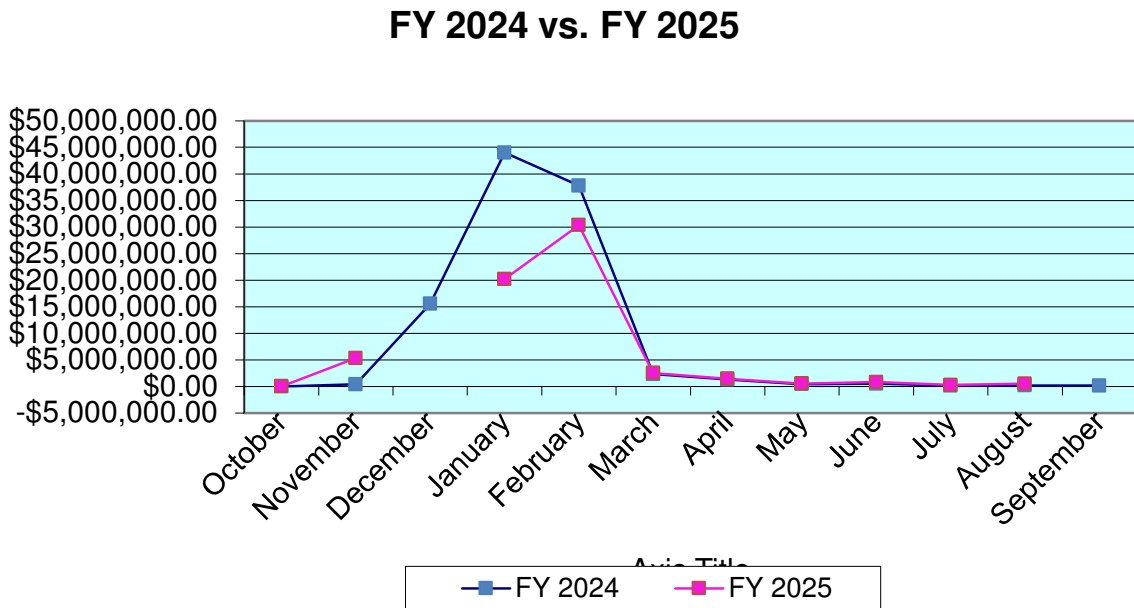
