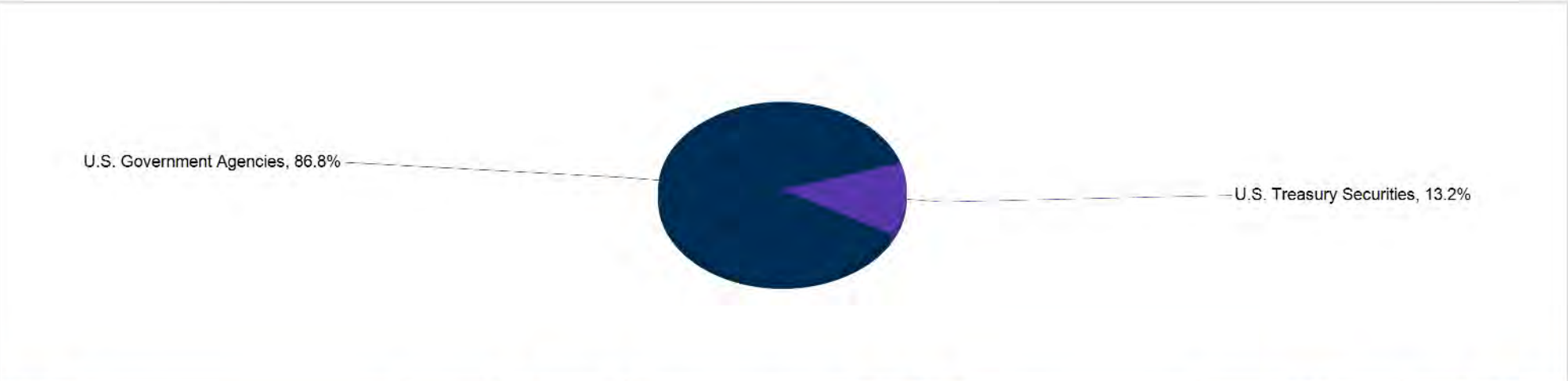

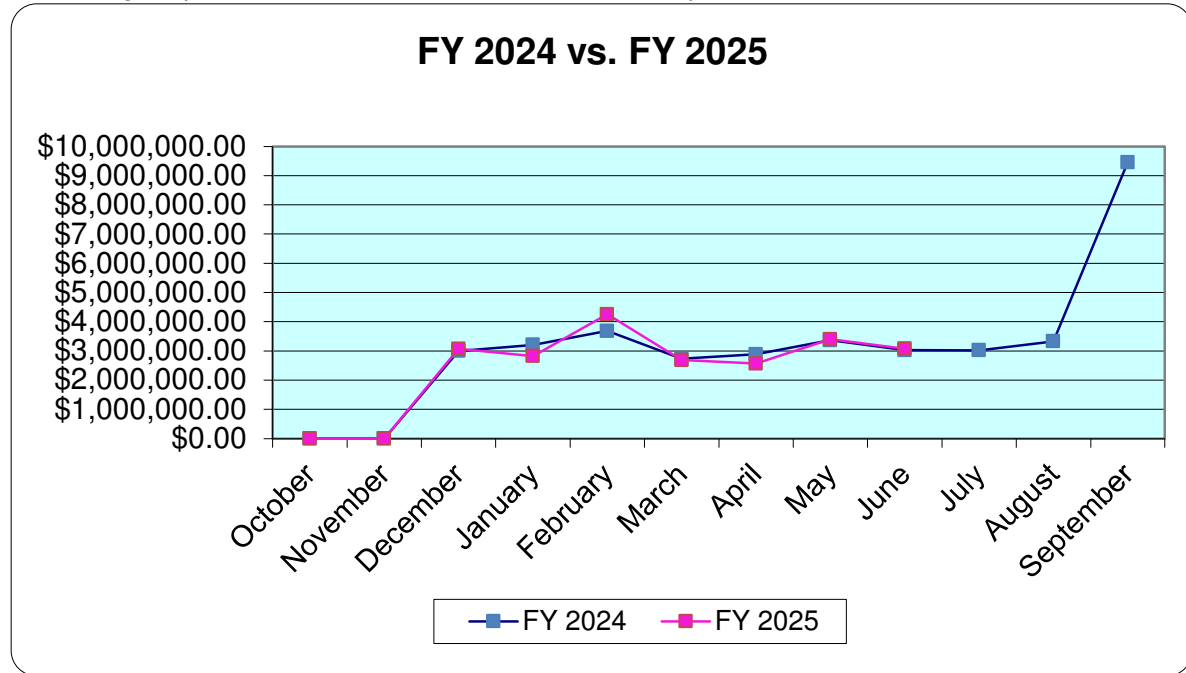

As of June 2025

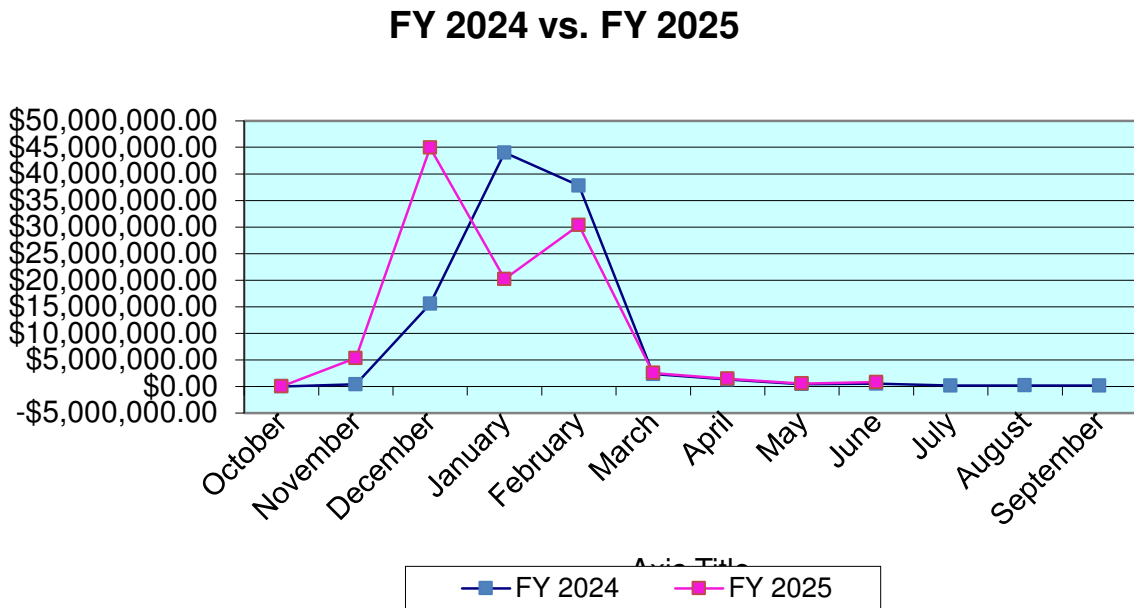
